

Sealed Tender Call Notice is hereby invited from the interested parties for sale of Govt. office vehicle bearing Regd. No. OR-15-B-3695(MAHINDRA JEEP) of Town Planning Unit, Phulbani. 

2. The vehicle will be handed over on "as is where is basis".
3. The interested party can quote the amount for purchase of vehicle in words and figure neatly without any over writing.
4. The name, address, contact details and quoted rate shall be submitted in the format given at **Annexure-A**.
5. Each quotation shall accompany with required Bank Draft of Rs.1000/- (Rupees one thousand) only. The BD of highest bidder will be later adjusted towards the amount quoted. The BDs of other bidders will be refunded. The Bank Draft will be prepared in favour of Town Planning Unit, Phulbani payable at Phulbani.
6. The quotation shall be submitted in sealed cover addressed to the Assistant Engineer, Town Planning Unit, Phulbani and dropped in the tender box kept in the office chamber of at Town Planning Unit, Phulbani during office hours on all working days from **05.01.2021 to 19.01.2021**.
7. The sealed tender papers will be opened on dated **20.01.2021 at 11.00 A.M.** in presence of Assistant Engineer, Town Planning Unit, Phulbani, and bidders or their authorized representatives in the office chamber of Assistant Engineer, Town Planning Unit, Phulbani.
8. The Offset Price has been fixed as Rs.35,000/-, any quotation less than the Offset Price shall not be considered.
9. The highest offers at or above, the minimum price shall be approved by the Assistant Engineer, Town Planning Unit, Phulbani at the time of opening of sealed tender papers.
10. The highest tenderer **SHALL** deposit 25% of the bid amount immediately after the announcement and the rest within 07 days of approval of the offer.
11. On failure to make payment, as aforesaid, the deposit amount including earnest money shall be forfeited and the vehicle will be put to fresh tender.

12. The vehicle shall not be delivered to the tenderer until after full payment and compliance with the requisite formalities.
13. Tools, implements and spare parts shall not be delivered with the vehicle.
14. The tenderer shall remove the vehicle from the site within seven days from the date of depositing the full amount of bid /tendered money.
15. The custody and safeguard of the vehicle shall be the responsibility of the tenderer and no claim or complain on that account shall be admissible.
16. On failure to remove the vehicle within the time, as aforesaid, the ground rent @1% of the tendered money shall be charged for each day or part of the day till the removal of the vehicle from the site.
17. Whether the ground rent, so charged, exceeds the sold price deposited, the tenderer shall seize to have any right on the vehicle and the amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt. free from encumbrances and disposed of by fresh auction or tender as the case may be.
18. The statutory cost of transfer of ownership of the vehicle will be borne by the tenderer.
19. One person can submit only one quotation.
20. The Assistant Engineer, Town Planning Unit, Phulbani reserves the right to cancel/reject the tender at any time.
21. All disputes are subject to the jurisdiction of Phulbani only.


