- Sale of Tender paper :-** The tender documents will be available in the Official website <http://www.kandhamal.nic.in> from date **1.3.2021 TO 19.3.2021** up to 5.00 P.M and can be downloaded from the website. In case any tenderer fails to download the tender paper, he/she may contact the Office of BDO, Tumudibandh for a softcopy during office hours from **1.3.2021 TO 19.3.2021** during office hours on payment of Rs.200/- per CD.
- The tenderer must pay non-refundable service charges as mentioned against the above works in shape of Bank draft from any nationalized bank payable to Tumudibandh drawn in favour of BDO, Tumudibandh or else the tender paper will be rejected.
- Bidders submitting downloaded bid documents from official website of NIC, Kandhamal (<http://www.kandhamal.nic.in>) are requested to deposit the requisite non-refundable fees of Rs.6000/- in shape of demand draft prepared on or before last date of sale of tender paper and submit the same alongwith the bid keeping in a separate envelope marks cost of tender documents downloaded from the internet.
- Receipt of Tender Paper:** The tender paper will be received by registered post/ speed post only upto 3.00 P.M till **23.3.2021**. Sealed tender papers must be accompanied with attested copies of valid contractors licence, GST Certificate, PAN Card, No relation certificate, Non-refundable service charges, EMD @ 1% of the amount put to tender in shape of NSC/KVP/POTD/Deposit of any schedule bank duly pledged in favour of the BDO, Tumudibandh and an affidavit regarding authenticity of the documents produced without which the tender paper is liable for rejection. The tenderer must write in capital letters (TENDER PAPER) on the right site top corner of the envelope containing the tender documents.

8. The engineer bidders seeking exemption of EMD must submit their original licence at the time of opening of tender papers failing which the tender is liable for rejection.
9. The authority will not be responsible for any postal delay even if dispatched before due date.
10. The successful bidder quoting less than the amount put to tender has to deposit the differential amount i.e (Tender schedule amount -(minus) his tendered amount) in shape of NSC/KVP/POTD/Deposit receipt of any schedule bank duly pledged in favour of BDO, Tumudibandh, at the time of agreement.
