1. The sealed quotations/tenders should reach the undersigned **on or before 15.04.2020 at 11.30 A.M and will be opened on the same day at 1.00 P.M in the office chamber of Tahasildar, Tahasil Office, Balliguda** in the presence of the bidders or their authorized representatives. If this day is declared later as Government holiday, the quotations/tenders will be received and opened on the next working day as per the scheduled time.
2. The quotations/tenders received beyond the stipulated date and time and incomplete quotations in any respect shall not be taken into consideration and liable for rejection. The Tahasil shall not be responsible for any postal delay.
3. The quotation/tender documents completed in all respect must be submitted by the bidder **by Registered Post/Speed Post/Courier Service addressed to the Tahasildar, Tahasil Office, Balliguda Dist.- Kandhamal, Pin -762103.**
4. The sealed quotation/tender documents must be superscribed on the cover **"QUOTATION FOR ENGAGEMENT OF VEHICLE"**.
5. The vehicle must be in Road worthy condition, shall not be more than **3 (Three) Year** old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.

6. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
7. The Driver should be well behaved, gentle and obedient in nature.
8. A sum of **Rs.5000/-** shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Tahasildar, Balliguda payable at SBI, Main Branch, Balliguda and submitted along with the tender as Security Deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
9. The monthly rate of hire charge should be quoted separately in the General Bid Information (excluding fuel and lubricants)
10. The Vehicle must achieve a fuel efficiency of minimum 10 Kms. per litre.
11. The owner of the vehicle should not claim the fuel beyond 10 Kms. per litre as his own fuel.
12. The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms. covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the General Bid Information to be furnished with the Quotation (Annexure-III)

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as :- Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hired shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty throughout the month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges bill of the selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bill along with the Log Book by the owner and no advance payment will be made.
9. The vehicle shall not be more than 3 (Three) Years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give 7 days' notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

If the bidder violates any of the terms of contract, Tahasil Office, Balliguda shall forfeit the entire amount of security deposit.
