

The sealed Tender paper shall be dropped in a sealed box available with the Section Officer in the division Office from **13.05.2021** within working Hours i.e. from 7.00 AM to 1.00 PM on any of the working day till **5.00 PM of 25.05.2021**. The sealed tender Box will be opened by the Tender Committee of the Divisional Forest Officer, Balliguda Forest Division on **26.05.2021 at 11.30 AM** in presence of the tenderers or their authorized representatives. Tenderers are required to submit two sealed covers i.e. (1) Technical Bid and (2) Financial Bid superscribed on the top of the envelope. During opening of the sealed tender, The **Technical Bid tenders** will be opened first and after scrutinizing the Technical bid the **financial bid of successful / qualified technical bidders** will be opened. The result of the tender will be published on **26.05.2021** itself. If two or more valid Tenderers are found to be same in the rate quote , then, transparent lottery will be held on the same day immediately in the office of the Divisional Forest Officer, Balliguda Forest Division in presence of the Contractors or their authorized persons.
