If nobody is present from the side of the quotations at the scheduled date and time, the Committee will not wait for opening of the tender.

Detailed Specification for Hoarding

- Size of Hoarding 5' x 10'
- Hoarding Material Sun Board of 3 mm thickness using Eco solvent vinyl printed process as per the prototype supplied Flex in best quality digital multi coloured printing.
- Support structure: Good quality surface angle frame comprising of Joist - 5" x 2.5", Angle - 3" x 3" and Angle - 2" x 2". Three feet deep concrete on each Pole of the Board alongwith supporting iron angle. Flex will be fixed by iron pipes and GI wires. The structure of the hoarding will be 5 feet height from the ground level.

The Tenders should accompany with the following documents

The Tender received without fulfilling the above terms and conditions shall be treated as prima face rejected and shall not be taken into consideration.




