7 The material should be supplied within 15 days from the date of placement of order. The material should be delivered in full and in good condition. Quality of the product will be given priority.

8 If any of the suppliers fails to supply the material within the stipulated period, the order will stand automatically cancelled and EMD so deposited by him forfeited.

9 The authority reserves the right to reject any or all tenders/ supply order without assigning any reason thereof.


10 Supply of material other than the sample approved will warrant rejection of the material supplied and resulting in forfeiture of the EMD.
