**Terms and Condition**


1. Bid Document can be obtained from the office of the undersigned on payment of Non-refundable cost as above in shape of Bank Draft drawn in favour of Block Development Officer Tikabali Payable at SBI/UGB Tikabali on the working days as at Col.07.
2. The Bid Document is to be received in complete shape in the tender box available in the office of the undersigned and opened on the date and time as Col.07 & 08. The under signed is not responsible for any delay or non receipt of papers in time. It must be super scribed as "**Bid for Construction of Block Office Building**".
3. The following documents should be furnished with the tender failing which tender will be liable for rejection- Self attested copy of (a) Contract's registration certificate (b) PAN Card (c) Valid GST Clearance Certificate (d) Caste certificate issued by competent authority in case of SC/ST contractors desirous of availing preference on demand.
4. If any bidders quotes more than or equal to 15% less of the tender value, than such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bid and the provision laid down in clause no 36 of Memorandum no. 12366 dt 08/11/13 of works department Govt of Odisha.
5. Additional performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as additional performance Security (APS) in shape of Demand Draft/Term Deposit receipt pledged in favour of the Block Development Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.
6. Submission of more than one tender paper by a bidder will be liable for rejection of all such tender paper submitted by him.
7. As the work is time bound critical in nature no extension of time will be allowed. The contract would be closed automatically when time period is lapséd. In this matter no communication will be made with the contractor.
8. Within three days from signing of the agreement he should show his machineries to the engineer in charge and commence the work immediately, Photographs of machineries along with the department staff should be produce to the authority.
9. On review of the last performance of the work executed through Block Development Officer Tikabali the lowest one tender may or may not be consider for the work though he/she become lowest one tender.
10. The contractors who have failed to execute the project of this agency/back out from execution process/ abandoned the project midway / those who have declared by this agency to be defaulters will not be allowed to participate in the present tender process. If any such contractors participates then his or her papers will not be consider at all.
11. The authority reserves the right to cancel or reject any or all bids without assigning any reason thereof.




