TENDER CALL NOTICE

Sealed tenders are invited in the enclosed format from the intending Vehicle Owners of Kandhamal district for supply of Full Body Bolero four wheeler for the office of the Block Development Officer, Tikabali for use in MGNREGA work on monthly hire basis on the following terms and conditions.

1. The tender paper will be received by the undersigned on or before 22.11.2021 up to 05:00 PM through registered or speed post only and the same will be opened by the tender Committee on 23.11.2021 at 11.00 AM in presence of the tenderer or their authorized agent.
2. The tender papers should be addressed to the BDO, Tikabali with clearly written on top of the cover that **'TENDER FOR ENGAGEMENT OF VEHICLE'** with self addressed signature of the tenderer.
3. The vehicle must be road worthy condition and shall not more than **03(Three)** years old from the date of initial registration and must have valid Registration Certificate, Insurance, Fitness, Contract Carriage Permit, Proof of up to date Tax Payment etc. which are mandatory for plying of the vehicle (Copies enclosed).
4. The tender for the vehicle with life time of more than 03(three) and less than 05(five) years can be entertained if the monthly hire charges is within 22000/- and the vehicle of less than 03(three) years is not available.
5. A sum of Rs. 3,000/- shall be deposited by the intending tenderer in shape of Bank Draft in favour of the **Block Development Officer, Tikabali** as EMD. After completion of tender process the EMD of the unsuccessful tenderer will be refunded.
6. The driver of the Vehicle must have valid Driving License with sufficiently experience in driving transport passenger vehicle and well behaved, gentle and obedient in nature.
7. The maintainace charges including repair/ replacement of spare parts, remuneration of the driver etc. shall be borne by the Vehicle owner.
8. The hire and fuel charges shall be paid to the owner on monthly basis on submission of complete vehicle log book with fuel voucher.
9. The tender is required to mention the hire charges per month clearly with No. of Kilometers per one litre of fuel.
10. In no circumstances the vehicle shall be used in any other purpose by the owner except specific permission of the undersigned and Parking will be made inside the office premises.
11. The authority deserves the right to modify/reject/cancel the tender without assigning any reason thereof.
