Applications are invited for filling up Gram Rozgar Sevak (GRS) under MGNREGA for Kandhamal District on contractual basis with a consolidated monthly remuneration @Rs.7,000/- (Rupees seven thousand) only which may be revised with approval of Government.

Eligibility:

- Age: The age of the applicant shall not be below 18 years and shall not be exceed 40 years as on 1st September, 2023. Age should be determined as per the matriculation/HSC certificate of the candidate.
- 2. There will be reservation for Ex-Servicemen (3% of the vacancies).
- There will be reservation for Persons with Disabilities (PwDs) with the following categories of benchmark disabilities under clause (b) & (c) of Section 34 (1) of Right of person with disability Act, 2016 namely,
 - (b) Deaf and hard of hearing
 - (c) Locomotors disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.

Reservation will be 4% of the total number of vacancies proposed to be filled up, out of which 2% shall be reserved for the persons with the above benchmark disabilities.



4. Educational Qualification:

The minimum qualification of the candidates should be 10+2 pass or its equivalent qualifications as notified from time to time by CHSE, Odisha with computer proficiency of "O" level and use of Odia language in computer. Computer proficiency is only qualifying in nature and shall not be count for determining the order of merit.

The candidature of candidates applying for the post of GRS having qualification (s) like PGDCA, BCA, MCA, M.Sc. (Computer Science) from Government recognized organizations/universities being higher than "O" level may be considered, provided such candidate fulfill all other eligibility criteria prescribed in the extant guidelines. The candidates whose PGDCA certificate is obtained before completion of Graduation will not be considered.

In order to ensure that the candidates applying for the post of GRS have adequate computer proficiency of a desirable standard & to check the menace of fake computer proficiency certificates, the candidature of the candidates submitting PGDCA certificates from organizations other than Government recognized institute/university shall not be considered.

Further, the courses need to be certified by, in pursuance of letter No.12175/dated, 30.07.2021 of Govt. in P.R. & D.W. Department, Odisha;

- (a) the certificate on basic computer proficiency covers with foundation level knowledge in computer application issued by the Training Institutions i.e. OS-CIT Certificate by OKCL & O-Level Certificate by NIELIT is valid, which can be verified from the Portal (<u>www nielit govt in</u>).
- (b) Likewise, other higher courses such as BCA, PGDCA, MCA are also need to be certified by Central Universities/ State Universities/Deemed Universities/ State Private Universities whose list finds place in UGC Portal (www ugc ac in) or by All India Council for Technical Education (www aicte-india org) or SCTEVT (sctevtodisha nic in).
- 5. Domicile: The candidate should be a resident of Kandhamal District.

6. Criteria for selection:

The selection of candidates shall be strictly on the basis of marks obtained in 10+2. Mark secured in the 4th optional shall not be included. In case, two or more candidates secure the same marks in the examination, the candidate older in age as per date of birth in the HSC certificate (within the stipulated age limit) will be placed above the younger. If the age of two or more candidates is same, the candidate who has passed HSC examination earlier will be placed above the other in the select list.



How to apply:

- Candidates must go through the details of the advertisement available in the district website (www.kandhamal.nic.in).
- The candidates should send their application through Registered Post/Speed Post only to the Chief Development Officer-cum-Executive Officer, Zilla Paris had, Kandhamal, P.O.-Phulbani, Pin- 762001 by superscribing on the envelope as "APPLICATION FOR THE POST OF GRS" within the deadline along with all required documents as per the advertisement uploaded in the website. The candidates are advised to go through the terms & conditions, scrutiny, verification & engagement details before applying for the position.
- The application form (at Annexure-A) should reach to the Zilla Parishad, Kandhamal on or before 10-10-2023 by 5.00 P.M. positively and application forms received lately after stipulated date will not be considered.

Terms & Conditions:

- Applications received incomplete, in any other format or through Courier Service, by hand, e-mail and other means shall be out-rightly rejected. The Authority shall not be responsible for any postal delay or other delay in receiving of applications.
- All posts are contractual in nature and the engagement is initially for a period of one year which can be extended depending upon the requirement and satisfactory performance.
- The candidates will be engaged in any Gram Panchayat of the District by the Collector-cum-CEO, Zilla Parishad.
- An undertaking should be submitted by the selected GRS prior to engagement as per the prescribed format at Annexure-B.
- Candidate must have Odia as MIL up to Class VII or passed in Odia language test equivalent to ME standard conducted by BSE, Odisha, Cuttack.
- The selected GRS will execute an agreement with the Collector-cum-CEO, Zilla Parishad with in non judicial stamp paper and the Collector-cum-CEO, Zilla Parishad issue engagement order after execution of agreement.
- Collector-cum-CEO, Zilla Parishad is the disciplinary authority of the GRS and is competent to terminate the contract and disengage the GRS on the grounds of violating the terms & conditions of engagement.
- If any fraudulent testimonial is detected in future or if he/she has been criminally prosecuted, the engagement shall be cancelled without notice and action as deemed proper will be taken against him/her as per the provision of Law.
- The post of GRS is transferable in nature within the district. The Collector-cum-CEO, Zilla Parishad is the competent authority to transfer the GRS from one Gram Panchayat to another Gram Panchayat within the district in view of exigency of public service or in consideration of genuine grievance or on administrative ground.
