

NOTICE

In pursuance to the letter No.20818/SSD/ dated 07.10.2023 of Commissioner-cum-Secretary, Government in ST & SC Development Department, Odisha, this office Notice No.2606 dtd.20.11.2023 and recommendation of the selection committee, ITDA, Phulbani following Vendors are provisionally empanelled (Annexure-I) with the following terms and conditions for the year 2023-24.

- (i) The Vendor has to provide material and labour as per requirement/ requisition given by the JE/AE with specification and Brand.
- (ii) The Vendor has to supply quality materials as per specification & Brand, skilled/unskilled labour with the satisfaction of the authority.
- (iii) The Vendor has to provide material and Labour in-time without any delay as per requirement.
- (iv) In case of supply of low quality /sub-standard materials, the Vendor will be black listed.
- (v) The Vendor has to supply under supervision and monitoring of concerned AEs/AEE.
- (vi) The Vendor has to provide material and Labour to the proper location as specified by the concerned AEs/AEE. He/She can claim transportation cost for the purpose and will be paid as per OPWD Code.
- (vii) The empanelment does not empower to Vendor any right to claim/to supply materials/ Labours. Its solely depends on the requirement and suitability.
- (viii) The Vendor shall be submitted the required G.S.T. Invoice/Bill/Voucher of the materials etc., that captures the transaction and tax details.
- (ix) The cost of Cement, MS Rod will be paid to the Vendor as fixed by the D.R.D.A. tender committee, Kandhamal.
- (x) The Vendors has to engage Labours as per requirement & submit the necessary muster roll dully signed by the Labours engaged in the works, in case non-availability of Labour Licence.
- (xi) Income Tax shall be deducted from the Vendors as applicable by the provisions.
- (xii) The list of empanelment is purely temporary in nature and the authority deserves the right to cancel, reject or expel any Vendors from the list without assigning any reason thereof.
- (xiii) The authority deserve the right to add, amend or delete the terms and conditions in consonance the Govt. guidelines time to time if required.
