

The Project Administrator, ITDA BALLIGUDA on behalf of the Governor of Odisha invites **Percentage Rate bids in Double cover system** in online mode for construction of work(s) as detailed in the table below, from **eligible** contractors registered with the State Government and contractors of equivalent Grade / Class registered with Central Government / M.E.S. / Railways.. The proof of registration from the appropriate authority shall be enclosed along with the bid. The successful bidder who has not registered under state Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.

Bids must be accompanied by Earnest Money deposit/Bid Security of the amount specified for the work in the table at Col.5 above, duly pledged in favour of **Project Administrator, ITDA, Balliguda** as specified for the work at Col.-02 of above table and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipments from outside of the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender as Bid security.
4. The Bid documents will be available in the website: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from 17.00 hours of Dt.27.12.2023 for online bidding.
5. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
6. The authority will not held responsible for any technical snag or network failure during online bidding.
7. Bids shall be received only "online" on or before 17.00 hours of Dt. 08.01.2024.
8. Bid documents received online shall be opened at 11.00 hours of Dt.09.01.2024 in the Office of the Project Administrator, I.T.D.A., Balliguda in the presence of the Bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of the bids after logging on to the site through DSC. If the Office happens to be closed on the date of the opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
9. As all works are time bound and critical in nature no extension of time will be allowed. If the work will not completed in the assigned schedule time with a valid reason, the work order is deemed to be cancelled without giving any reason thereof. No further communication will be made.

10. Within 3days from signing of the agreement the contractor should show his machineries to the Engineer in charge and commence the work immediately. Photographs of machineries along with the Department Staff should be produced before the authority.

12. LIST OF PLANT AND EQUIPMENTS TO BE DEPLOYED ON THE CONTACT WORK must be submitted vouchers (owner/ affidavit)
13. Document submitted by bidder should be page numbered and reflected in separate index page.

15. Bids of non performing and habitually slow contractors will be rejected.
16. The authority reserves the rights to cancel any or all bids without assigning any reason.
