i) Videography by digital camera:

The video coverage will cover all aspects of the exhibition starting from inaugural function, Gates, hoardings, Design of the exhibition, workshops, seminars, views of public, views of participants, cultural programmes & valedictory function. All the above aspects should be covered in consultation with the Mela authority. 
