Sealed quotations in plain papers are invited from reputed Caterers/food Suppliers of Kandhamal District having valid GST, PAN & food license from health department & experience in catering Service for supply of cooked food to the Sports persons/Artists/ Participants/Guest to be attended in the **District level Tribal Sports & Cultural Festival** scheduled to be held from **12th February to 14th February 2024** at Stadium Ground & Coronation Ground, Phulbani.

The details of date wise food requirements & menu with specifications are given in the statement. Intending caterers/food suppliers having GST approval and previous experience in mega events may apply in the office of the P.A., ITDA, Phulbani by hand/post from 10.00 AM to 3.00 PM by 10.02.2023. The quotation will be opened on the same day in the office chamber of the P.A., ITDA, Phulbani, Kandhamal, at 04.00 PM in presence of the Bidders /authorized representatives.

The intending Caterer or food supplier shall quote the specific rate of breakfast, lunch, dinner including 15 numbers of round tables and chairs, kitchen set, with provision of light, two hundred chairs for sitting purpose, utensils, distribution table and service person with proper uniform. Food should be prepared for 1200 to 1400 persons basing on the order from the previous day.

Terms and Condition:-

1. P.A. I.T.D.A., Phulbani, reserves the right to accept or reject any tender without assigning any reason thereof.
2. Quotations received after due date and time will not be accepted. Project Administrator, ITDA, Phulbani shall not be responsible for postal delay or similar reasons. No Tenders sent through an electronic means shall be accepted.
3. The Technical Bid will be opened on dated 10.02.2024 at 4.00 P.M. in presence of the bidders or their authorized representatives before the tender committee.
4. All the documents must be self-attested by the Bidder/Supplier.
7. If the Technical Bid is found complete in all respect, then only financial bid will be opened, otherwise Financial Bid will be returned to the bidder without opening it.

As per of its Technical bid submission, the bidder/Supplier would be required to submit an earnest money deposit amounting to Rs.14,000/-**(Rupees fourteen thousand)** only in form of a demand draft. The demand draft should be in favour of Project Administrator, ITDA, Phulbani payable at Phulbani. The Draft should be prepared after the publication of the Tender call notice.


