b) Successful bidder should submit the details of longitude, latitude, Survey report, including quantification of the legacy site along with the 3D map of the existing dump site.

c) The selected bidder will bear all the cost, as per the scope of the work, including submission of all the documents and report, as per requirement.

d) In case, more than one bidder, quotes the same lowest price, then the tender accepting authority will finalize the tender, through a transparent lottery system. in the presence of the authorized representative of the bidder.

e) The selected bidder will complete the assignment, within one month of the issue of work order.
