

The proof of registration from the appropriate authority shall be enclosed along with the bid. The successful bidder who has not registered under state Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.

Bidders desirous to hire machineries or equipments from outside of the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender as Bid security.
- The Bid documents will be available in the website: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from 11.00 hours of Dt.12.03.2024 for online bidding.
- The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- The authority will not held responsible for any technical snag or network failure during online bidding.
- Bids shall be received only "online" on or before 17.00 hours of Dt. Dt.19.03.2024 .
- Bid documents received online shall be opened at 11.00 hours of Dt.20.03.2024 in the Office of the Project Administrator, I.T.D.A., Balliguda in the presence of the Bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of the bids after logging on to the site through DSC. If the Office happens to be closed on the date of the opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
- As all works are time bound and critical in nature no extension of time will be allowed. If the work will not completed in the assigned schedule time with a valid reason, the work order is deemed to be cancelled without giving any reason thereof. No further communication will be made.



15. Bids of non performing and habitually slow contractors will be rejected.
