The appointment is purely temporary and terminable at any time without assigning any reason thereof with the following terms and conditions;

- 1. If any Misappropriation, Vigilance / Criminal case detected against the selected Accountant-cum-DEO on the date of their appointment order issued will be terminated without any notice to the person concerned.
- 2. After selection, the candidate shall be appointed provisionally in the service for a period of Two years on probation basis.

Provided that the appointing authority may if think fit in any case or class of cases for good and sufficient reasons to be recorded in writing, extend the period of probation for another year but not exceeding two years.

Provided further that such period of probation shall not include

- a. Extraordinary leave
- b. Period of un-authorised absence or
- c. Any other period held to be not being on actual duty
- 3. The selected Accountant-cum-DEO will be imparted with institutional computer training of 3 months and Accounting training of 3 months. They shall be required to pass the training course during the first year of the probation period.
 - a. A maximum of 3 (three) chances shall be allowed to trainees to pass the training course.
 - b. A pass in the computer training and accounting training shall be one of the basic criteria for satisfactory completion of the probation.
 - c. After satisfactory completion of the probation, the candidate shall be regularised in the service. The appointment of the candidates who failed to clear the training in 03(three) chances shall not be extended further.
- 4. Inter-se-seniority will be maintained as per the gradation of GRS in accordance with Rule 13 and Rule 14.
- The Accountant-cum-DEOs appointed herewith are directed to submit their joining report before the respective BDO along with required documents.
- 6. She/he should submit the following documents before the Block Development Officer concerned at the time of her/his joining in the post failing which joining report shall not be accepted. i.e.
 - a. Educational qualification
 - b. Medical Certificate as required under Rule-49 read with Rule-50 of Odisha Service Code.
 - Two Character Certificate from two different Gazetted Officers not being the relatives to the candidate.
 - d. Declaration to the effect that the candidate has not more than one spouse living.
 - e. Caste Certificate.
 - f. Oath of allegiance to the constitution of India.
 - g. A declaration to the effect that he/she has no criminal antecedent and no pendency of any criminal case against him/her.
 - 7. She/he shall abide by the Odisha Civil Services Conduct Rules, 1959 and OCS (CC&A) Rules, 1962.
 - 8. They shall be enrolled under the New Pension Scheme contained in the OCS (Pension) Rules, 1992 from the date of appointment.
 - 9. If any violation or wrong information detected in future, as per the notification No 4727 dated 27.02.2024 of Govt. in PR & DW Department, Odisha the candidature shall be rejected and she/he will be terminated.
