Quotation Call Notice

Sealed quotations are invited from interested reputed Travel Agencies/Tour Operators or private individuals for hiring one no. of Petrol/Diesel Driven, which shall conform to the terms and conditions (Annexure-11) for official use in District Child Protection Unit, Kandhamal on monthly rent basis as given below.

i) TUV 300/BOLERO/Sumo Gold/Ertiga: Maximum hiring charges Rs.31000/- per month and having fuel efficiency of 10/km/ltr.

1. The vehicle must be in RoadWorthy condition, shall not be more than three years old from the date of initial registration, and must have a valid Registration Certificate. Insurance Certificate. Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment. GST no etc. which are mandatory for plying of vehicle.

2. The driver of the vehicle must have a valid Driving License for driving a light transport passenger vehicle and should be sufficiently experienced in driving a transport passenger vehicle.

3. The Driver should be well behaved, gentle and obedient in nature.

4. A sum of Rs. 5,000/- shall be deposited by the intending bidder in shape of Account Payee Bank Draft drawn in favour of the District Child Protection Officer, DCPU, Kandhamal and submitted along with the tender as a security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidder

5. The monthly rate of hire charge be quoted in the general bid information which be maximum upto Rs 31,000/- (excluding fuel and lubricants).

6. The vehicle must achieve a fuel efficiency of 10 Kms. Per litre,

7. The details of the make and year of manufacture of the vehicle, registration No. mileage (Kms. Covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation (Annexure-III).

8. The quotation completed in all respects should reach the undersigned on or before 19.06.2024 by 05.00 PM and shall be opened on 20.06.2024 at 11.00 AM in the presence of the bidder or their authorized representative.

09. The application form of quotation containing General Bid Information. & Terms and conditions for Hiring of vehicles etc, will be available in the District Website www.Kandhamal.nic.in which can be downloaded for application.

10. Petrol vehicles are preferred as per Government instructions.

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificates, Insurance Certificate, Fitness certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc./and DL of the driver available all the times. The office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damaged to any property on account of use of hired vehicle any manner whatsoever.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel/petrol which is to be paid separately basing on acted consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of break down for reasons whatsoever the replacement of the vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of vehicle do not report regularly, the authority will be at Liberty to reject the agreement and may engage vehicle from other source.
6. In case of emergency the driver will have to report for duty as per the requirement of the hirer. No extra payment shall be demanded.
7. Monthly hire charges and reimbursement towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, and no advance payment will be made.
8. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
9. If the services are found to be unsatisfactory, the vehicle will be disengaged without any notice,
10. In case service provider intends to withdraw the services of his/her vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
11. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
12. Initially the vehicle will be engaged for 1 year. The contract may be extended upon satisfactory service provided by the Driver/Bidder during the period.
