

Terms & Conditions


1. The firm should submit an EMD of Rs.20,000/- (Twenty Thousand Only) in shape of Demand Draft in favour of ZSS NON NRHM FUND, payable at Phulbani.
2. The firm should submit Tender fees of Rs.2,000/- (Two Thousand Only) in shape of DD in favour of ZSS NON NRHM FUND, Payable at Phulbani.
3. The Hotel/Firm must be situated in Phulbani Town.
4. The Hotel/Firm must have GSTRegistration certificate along with last three months GST return filling copy i.e. JAN-2024 to MAR-2024 .
5. The Hotel/Firm should have filed IT return for the FY-2022-23.
6. The Hotel/Firm should have own laundry facility for washing, drying and ironing.

The Technical & Price Bid envelopes should be clearly marked as Technical Bid & Price Bid on the top of the relevant envelopes. 


