TENDER CALL NOTICE

Sealed tenders are invited in the enclosed format from the intending vehicle owners of Kandhamal district for supply of one petrol/diesel vehicle (Bolero/ TUV/ Sumo Gold/Ertiga) having sitting capacity not more than five including driver, which shall conform to the terms and conditions for official use in the office of the Panchyat Samiti,Chakapad, on monthly rent basis on the following terms and conditions.

1. The tender paper will be received by the undersigned on or before **21.06.2024** upto 4.00pm through registered or speed post only and the same will be opened by the tender committee on the same day at 5.00pm in presence of the tenderer or their authorized agent.
2. The tender papers should be addressed to the Block Development, officer Chakapad, with clearly written on the top of cover that "TENDER FOR ENGAGEMENT OF VEHICLE" with self-addressed signature of the tenderer.
3. The vehicle must be road worthy condition and shall not more than 03 {three} years old from the date initial registration and must have valid Registration Certificate, insurance, Fitness, Contract Carriage permit, proof of up-to-date tax payment etc. which are mandatory for plying of the vehicle (copy enclosed).
4. A sum of Rs 5000/- (rupees five thousand) only shall be deposited by the intending tender in shape of bank Draft in favour of the BDO, CHAKAPAD as EMD. After completion of tender process, the EMD of the unsuccessful tender will be refunded.
5. The driver of the vehicle must have valid driving License with sufficiently experience in driving transport passenger vehicle and well behaved, gentle and obedient in nature.
6. The maintenance charge including repair/ replacement of spare parts, remuneration of the driver etc. shall be borne by the vehicle owner.
7. The hire charges shall be paid to the owner on monthly basis on submission of complete vehicle log book the monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricant)
8. The vehicle must achieve a fuel efficiency of 10 KM per liters.

9. The detail of the make and year of manufacture of the vehicle, registrations number, mileage (KMs covered per liter) and name of the driver with driving License No. Add period of validity should be specifically provide in the general bid information to be furnished with the tender.
10. The tender completed all respect should reach the undersigned on or before **21.06.2024** by 4pm and shall be opened on the same day at chamber of Block Development Officer, Chakapad, in presence of the bidders or their authorized, representatives.
11. In the event of similar price offered by more than one vehicle owner, the selection will be made through draw from lot.
12. In no circumstances the vehicle shall be used in any other purpose by the owner except specific permission of the undersigned and parking will be made inside the office premises.
13. The authority deserves the right to modify/reject/cancel the tender without assigning any reason thereof.
