INVITATION OF APPLICATION FOR ENGAGEMENT OF CRCCs ON DEPLOYMENT BASIS UNDER SAMAGRA SHIKSHA, KANDHAMAL

- (1) **Guidelines for Selection of CRCCs for Engagement** :- In pursuance of Letter No.2465/TT/03, Dtd.26-08-2003, Letter No.10219 (60)/Ped/07, dated.19-12-2007, Letter No.333/Ped/08, dated.10-01-2008, Letter No.3392/13, dated.30-04-2013, Letter No.10937/Estt./14, dated.11-12-2014, Letter No.2969/Ped/19, dated.11-04-2019 and Letter No.2349/Ped/19, dated.18-03-2019 of the State Project Director, OPEPA, Bhubaneswar, Letter No.3420/Estt/14, dated.29-04-2014 of Addl. Director (General) and Letter No.7147/Ped/10, dated.08-09-2010 of the Commissioner-cum-Secretary to Govt., S&ME Deptt & SPD, OPEPA and Memo No.6041,/Ped/22, dated.21-05-2022 and Memo No.12449/Ped/22, dated.30-09-2022 of OSEPA, Bhubaneswar, application forms are invited from the eligible Level-V Teachers under Elementary Cadre of Kandhamal district for selection of CRCCs in Samagra Shiksha, Kandhamal through Visioning Test on deployment basis.
- (2) **Vacancy Position** :- There are **64 nos.** of CRC Coordinator posts are lying vacant in different Blocks of the district which are to be filled up through visioning test. However, the vacancy position is subjected to vary keeping in view of vacancy from time to time and the authority reserves the rights to take any decision for filling up of vacancy as per the field requirement. The deployment of CRCCs will be made on the basis of Merit of Visioning Test. The decision of the Selection Committee is final.

(3) **Eligibility Criteria for Deployment of CRCCs :**

- (i) Teachers belonging to Level-V under Elementary Cadre are eligible for applying for the post of CRCC and he/she should have 5 years left for retirement. (as per Memo No.6041, dated.21.05.2022 OSEPA, Bhubaneswar).
- (ii) He/she is presently working in the Block to which he/she shall be posted as CRCC.
- (iii) Level-V Assistant Teachers (ex-cadre) are not eligible for the post of CRCC (as per Lr. No.6446/TT/18, dtd.05-07-2018 of OPEPA).
- (iv) The teachers having departmental proceedings / charges of misappropriation of funds/ criminal case pending shall not be allowed.
- (v) Teachers who have been disengaged from the post of CRCC due to different reasons i.e completion of 5 years of tenure, resignation, misconduct, administrative exigencies etc. shall not apply.

(4) **Terms & Conditions :**

- (i) The post of CRCC is purely temporary & not a regular or promotional post. The CRCCs will be engaged in the Clusters to be allotted to them on deployment basis.
- (ii) The CRCC will work as per the job chart / assignment under the immediate guidance of ABEO-cum-BRCC/BEO/DPC and any assignment as entrusted by the higher authorities from time to time.
- (iii) No claim shall be exercised by any CRCC for engagement to a specific cluster.
- (iv) If any allegation or insufficiency is found against any CRCC, he/she shall be disengaged and new CRCC will be engaged in his/her place.
- (v) Qualifying the Visioning Test ipsofacto, does not, confer any right to be posted as CRCC.
- (vi) The authority reserves the right to cancel/amend the order/disengage any CRCC at any point of time.

(5) **Documents to be submitted :**

The interested teachers having requisite eligibility criteria have to submit the following documents :

- (i) The detailed information in prescribed application-cum-bio data format and undertaking through Block Education Officers of the district.

- (ii) Self attested copy of all Educational & Professional Qualifications.
- (iii) Two recent passport size colour photographs (self attested).
