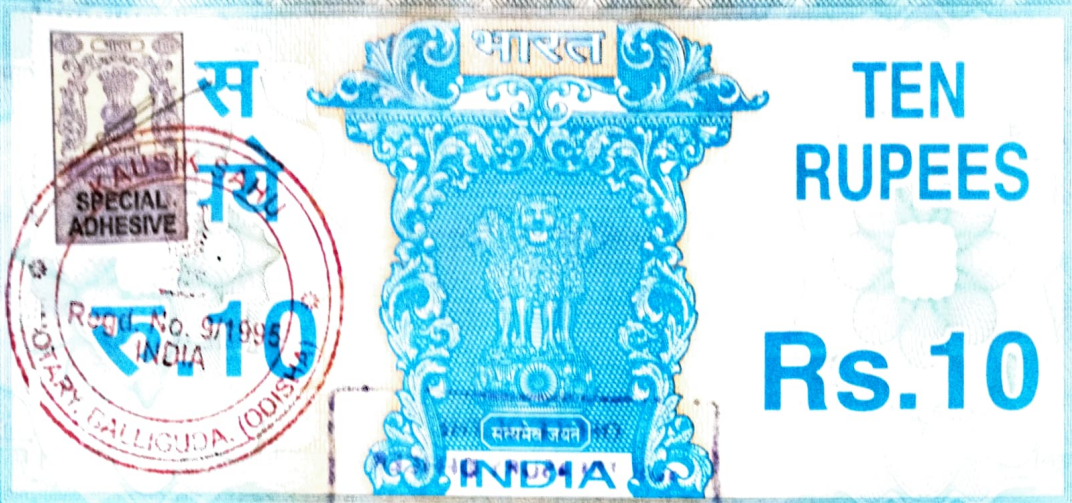

5. Other relevant documents & information as per 10th edition of Compendium of Instructions on Election Expenditure Monitoring.




