

- Safety of the public and persons in the road show should be ensured. Bursting of fire crackers and caring fire arms is not permitted.
- The Loud speaker shall be under low volume as far as possible (Not to exceed 65 Decibels).
- To mitigate the adverse effects of heat wave, necessary arrangements like drinking water, ORS supplement & availability of first-aid facilities should be ensured for the persons participating in the road show.
- The maximum size of banner to be carried with hand should be 6×4 feet.
- Display of animals in road show is totally banned. Children, particularly school children in uniform should not take part in road show.
- Only one flag of the size 1ft × ½ ft with permission of the RO concerned is permitted on campaign vehicles in road show.
- Length of pole/stick for carrying flag should not be more than 3 feet.
- No lathis or other dangerous weapons may be carried by anyone in the road show without obtaining special permission.
- Sufficient volunteers should be engaged to control crowd. No speech/slogan/plucked/banner should be used which is against any Community/Religion/State Govt.
- No person involved in any crime should be allowed to participate in the programme.
- Route chart should be submitted to the local authority and it should not be changed in any circumstance without obtaining special permission.
- In case of any emergency the permission may be cancelled.
