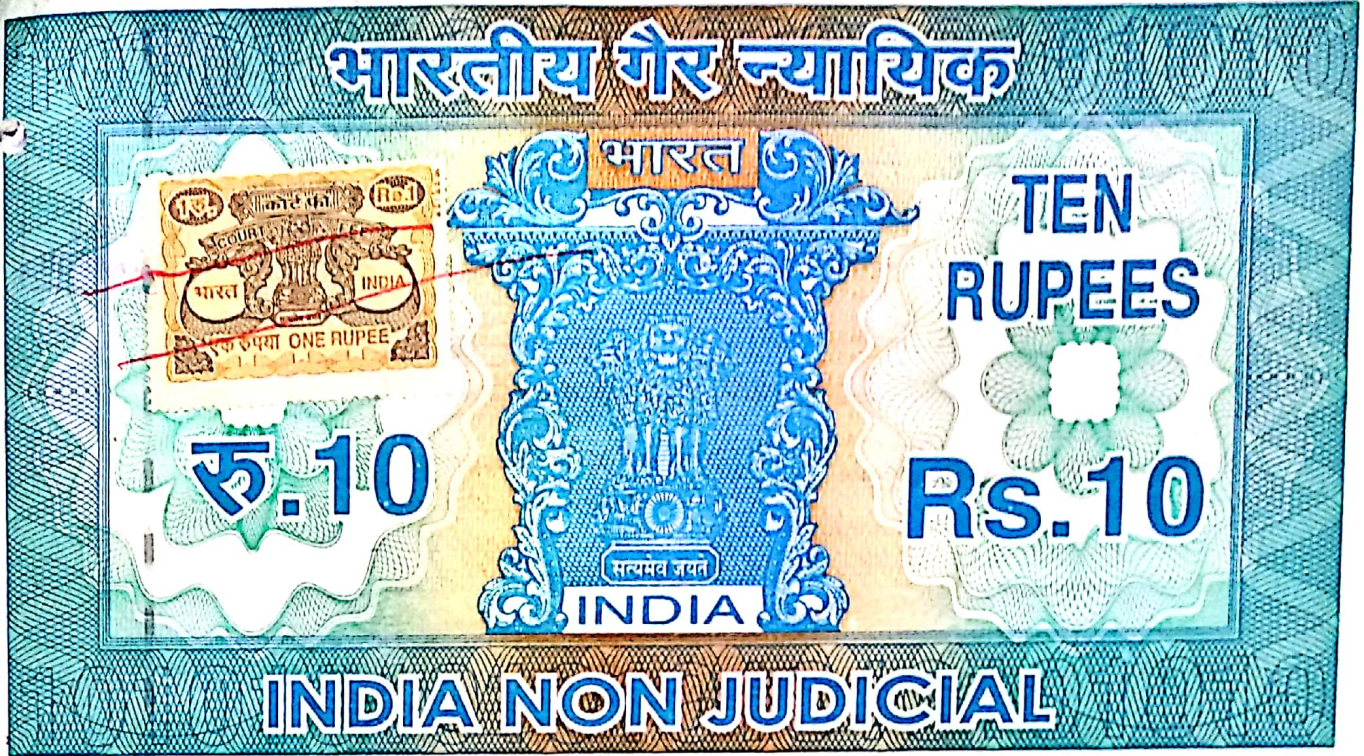

On verification of Day-to-day Register for the candidates on dated 14.05.2024 some lapses has been identified by the Election Expenditure Observation Team which are given bellow-


1. The expenses incurred on 01.05.2024 and 02.05.2024 is said to have paid through cheque but some amount is not appearing in Bank account.

5. Other relevant documents and information's as per 10th edition of Compendium of instructions on the Election Expenditure monitoring.




