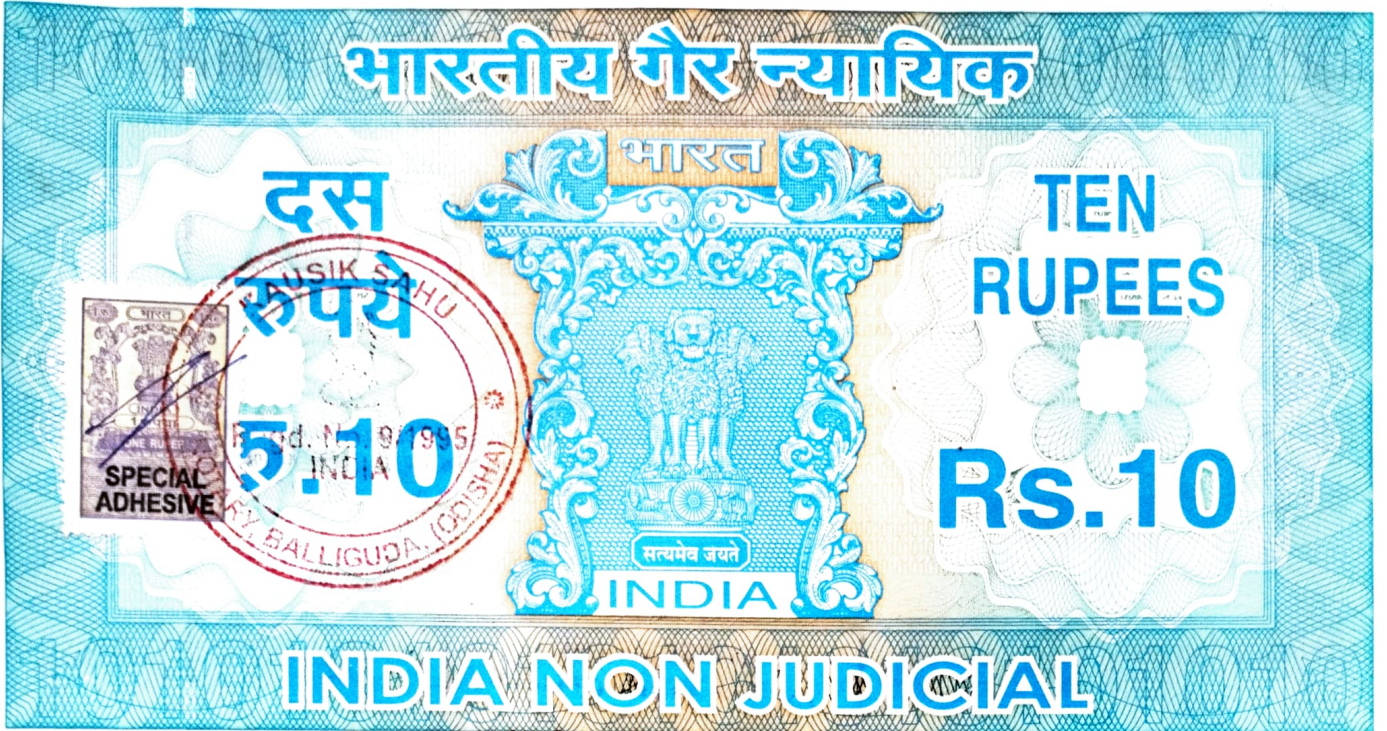

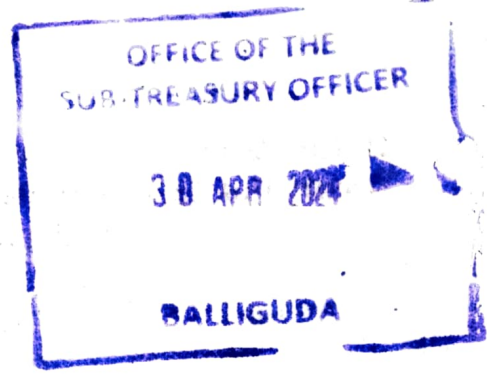

On verification of day-to-day Expenditure Register for the candidates some lapses have been identified which are given below.


1. There is no mention of bill/voucher Number in day-to-day Expenditure Register.

5. Other relevant documents & information as per 10th edition of Compendium of Instructions on Election Expenditure Monitoring.




