TERMS AND CONDITIONS

1. The staff and dependent of the staff of JNVs should not be awarded the tuck shop.
2. A security deposit may be charged from the successfully bidder/vendor.
3. Penalty clauses may be included in the terms of contract which may be operated by the concerned authority in cases of breach of terms and conditions of the contract.
4. Tuck shop ought to be operated on different days for girls' different days for boys not opened for both a single day.
5. No shop structure permanent/temporary may be created, instead vendor may sit at a designated place for a specified time with permitted items, and go back with all the balance items, when the shop timing gets over.
6. No storage facility should be provided to the vendor by the School.
7. Tuck shop should provide the additional stationary items, branded packed biscuits/muffins. No other cooked food/junk food and beverages should be provided from the Tuck shop.
8. The items should be sold at discounted price from the MRP. No expired items should be sold from the tuck shop.
9. Students can submit the requirement of any permitted item to the vendor in advance through the concerned HM/AHM.
10. Tuck shop facility should be available separately for boys and girls, it may be operational for maximum 2 hours between Lunch and evening sports & games.
11. The tuck shop should be opened maximum 04 (Four) days in a week. 02 (Two) days for boys, and 02(Two) days for girls separate day for boys and girls.
12. No telephone calling facility provide through tuck shop to students.
