The Govt. in Food Supplies & Consumer Welfare Department., Odisha, Bhubaneswar vide letter No. 15279/ F.S & C.W dated. 05.10.2024 have allotted a stock of 93 K.L S K. Oil for both NFSA & SFSS beneficiaries allotted to different Blocks through the Wholesalers of this District for lifting & distribution of the same as per the norms and conditions stipulated by Govt. for supply of K. Oil by the IOCL for the month of **October , November & December 2024.**

As per Government direction S.K. Oil will be distributed to the NFSA & SFSS Ration Card holders of the district @ **0.500 Ltrs.** per NFSA / SFSS card through e-Pos device.

The FPS-wise sales register also been made available for download in the e-PoS devices of those Fair Price Shops which have received the device to carry out PoS based distribution of S.K Oil entitlement of beneficiaries. This should be downloaded in PoS Device after 1st date of the allotment month and distribution should be made accordingly through PoS Device.

The allotted quota of SK Oil for October , November & December 2024 should be lifted and distributed to NFSA beneficiaries from **10th October to 30th November, 2024.**

Further, Minimum 25% verification of sale of S.K. Oil will be conducted by the Inspector of Supplies/ ACSOs / Addl. CSO in-charge of the Blocks/ULB every month.

The Un-distributed allotment of S.K. Oil will be considered as opening balance while finalizing the allotment for the next month.

The Wholesalers / Retailers are directed to lift the allotted stock as per the dateline positively. Stringent action shall be taken against the wholesalers / retailers who are not lifting the allotted stock in full and indulged in Black-marketing and diversion of PDS Kerosene for any other purpose. Wide publicity should be given about scale of supply of K. Oil and consumers selling price so that consumers will get actual quantity in notified price. A stock of **92553.6** liters of S.K.Oil is hereby allocated among different blocks/ULBs as per online status of cards of individual units.
