

**Advertisement for Selection of Ombudsman under MGNREGS**

Fresh expression of interest is invited from willing persons to be engaged as Ombudsman in Kandhamal district for redressal of grievances and disposal of complaints relating to implementation of MGNREG Act and MGNREG Scheme for tenure of 02 (two) years extendable not more than twice by one year each based on a performance appraisal process or till the incumbent attains the age of 68 (sixty eight) years, whichever is earlier. There shall be no re-appointment.

**Eligibility Criteria:** The persons fulfilling the following criteria may apply for the post of Ombudsman in Kandhamal District under MGNREGS.

- i. A person of eminent standing and impeccable integrity with at least 10 (ten) years of experience in Public Administration, Law, Academics, Social Work or Management. Experience in working with people or community organization shall be a mandatory qualification.
- ii. Preference be given to a resident of Kandhamal District or neighbouring district so as to take advantage of his/her firsthand knowledge about the district.
- iii. In case there is any vacancy due to resignation, removal, death etc., the person next in the approved panel shall be offered the appointment as Ombudsman without calling for a fresh meeting of the Selection Committee.
- iv. No person who is a member of a recognized political party or a banned organization shall be considered for appointment as Ombudsman. Each person shall be required to file a declaration to this effect along with the application.
- v. Must be a physically active person and capable of conducting field tours, inspection and visit to remote rural location in the district.

Appointment: The Ombudsman in the district will be appointed by the State Government on the recommendations of the Selection Committee of the state. No written test or examination shall be conducted while an interviews and an internal marking system will be evolved by the Selection Committee of the state to rank persons in order of preference. Prior to appointment, the panel prepared by the state selection committee be published on the official website of the state and the official website of the nodal department to invite comments from the public. On expiry of 30 (thirty) days of publication, the comments received be examined by the Selection Committee. It is clarified that the work of the Ombudsman is in the nature of pro bond public service and no posts are created in the state for the purpose.

Remuneration: Subject to any notification by the State Government, the Ombudsman shall be allowed compensation, in form of a fee, of Rs. 2,250/- (Two thousand two hundred fifty) only per sitting with maximum upper limit of Rs. 45,000/- (Forty five thousand) per month.

Removal: On unsatisfactory performance, the Ombudsman may be removed by the State Government on the recommendations of the Selection Committee of the state.

Jurisdiction and Location: The state Govt. shall specify the territorial jurisdiction of each Ombudsman in terms of a District and the office of the MGNREGS Ombudsman shall be located at District Head Quarters.
