
5. Bids shall be received in the office of the District Project Coordinator, Samagra Shiksha, Kandhamal, till dt. 20.03.2025 up to 5.00PM- through Registered Post/Speed Post. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.

6. Bidders shall submit an original affidavit regarding the authenticity of their documents and E.M.D. along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, GSTIN and PAN card, otherwise his/ her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest three bidders are to be produced before District Project Coordinator, Samagra Shiksha, Kandhamal, Phulbani for verification.

7. Bidders can submit one tender paper only. Submission of more than one tender paper by a bidder for particular work will be liable for rejection.

9. If the rate quoted by a bidder is **more than 15% less** of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at **14.99%**(Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, the tender inviting authority/ his authorized representative and Sr. Technical Consultant will remain present.

10. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. 


