





**Terms of Reference to the tender paper for organizing Meena Bazara during
Kandhamal Mahotsav-2025**

Terms & Conditions

1. Sealed tenders are invited from experience firms/ Agencies/ person for taking the Organization of Meena Bazar during Kandhamal Mahotsav and Pallishree Mela-2025 in a single work order.
2. The must submit an EMD of Rs.50,000/- (Rupees fifty thousand) only in shape of Demand Draft.
3. The bidders should have valid PAN & GST Certificate.
4. Copy of work orders/ experience certificate for similar nature of works in Odisha during last 5 years.
5. The bidder shall quote their price for all items without leaving blank. If found so the bid will be treated as non-responsive and rejected.
6. The authority is not bound to accept the lowest tender and reserves the right to inspect/verify the stock of materials required for this work, in Go-down of bidders by nominating a committee to ascertain the credibility of the firm. Further the undersigned reserves the right to reject any or all tenders without assigning any reasons thereof.
7. The bidder or the representative of the bidder should attend the opening event of the tender with all original documents/paper for verification, if required.
8. On completion of the Meena Bazar, the bidder shall have to take away all the material within 5 days of completion of Mahotsav and vacate the place.
9. Bidder will be responsible for cleaning and maintenance of the entire ground occupied by him till the closing of the exhibition. ORMAS/ Zilla Parishad, Kandhamal will not be responsible for any breakage, damage, fire, theft etc. of his material and insurance if any.
10. Bidder should be taken for coverage of insurance of the particular event.
11. The bidder is to submit self-attested photocopies of the required documents with duly filled in tender paper.
12. The bidder should obey the rules & regulations of Kandhamal Mahotsav-2025.



13. The Meena Bazar time between 10 .00 AM to 11.00 P.M every Day. After that the event should be closed. The sound system should not be disturbing the Mahotsav Management.
14. The bidders should prepare the aforesaid Meena Bazar field development work with their own cost.
15. The bidder should not allow to erecting any type of stall except Meena Bazar activities. In case of any additional requirement, the contractor has to take the prior permission from the Palishree Mela-incharge.
16. The selected bidder should hire own separate temporary electricity connection.
17. The tender will be sent to ORMAS, Kandhamal, O/o-Zilla Parishad, Kandhamal, At/Po-Phulbani, Dist-Kandhamal, Pin-762001 through Speed Post/ Registered post only. Tender received through other mode will not be accepted. The last date of receiving of the tender document is 5:00 PM of 13th Mar, 2025.

In case of any unsatisfactory work, delay in execution works etc. The EMD amount will be forfeited by the authority.

- III. Copy of the registration certificate/ valid number in favour of the firm from Commercial Tax dept GST certificate & PAN.
- IV. After finalization of the tender the selected bidder should submit the following documents within 2days unfailingly.

7. Workshop Engineer certificate from E.E (R&B), Kandhamal.
8. Authorization from any registered electrical contractor for execution of electrical work.
9. Mike permission from the competent authority.
10. The duration for the exhibition will be 5 days in case of any extension of Mela period no extra payment will be charged for the additional days. All the desired works should be completed at least one day before the scheduled inauguration date and time of exhibition.


