1. Application: the intending bidder may apply by downloading bid form and document from the website [www.kandhamal.odisha.gov.in](http://www.kandhamal.odisha.gov.in) and apply accordingly along with detail enclosures.
2. Place and date of receiving Quotation: Sealed Quotation will be received at District Child Protection Office, Kandhamal through Speed post/ Registered post/Courier only on or before 16.03.2025 at 5.00 P M. The sealed envelop superscribing "Quotation for supply of Electronics items" shall be sent to District Child protection Officer, Kandhamal, At- Mission Shakti Bhawan, DRDA Square, Phulbani PIN- 762001, Odisha. This office will not be responsible for receipt of tender paper beyond the stipulated date and time due to postal delay or any kind of delays.
3. Date, Time and Venue for opening of Quotation: The sealed documents shall be opened on 17.03.2025 at 11 AM in the conference hall of Collectorate, Kandhamal in the presence of bidders or their authorized representatives and the members of District level purchasing committee. The authority reserves the right to cancel/reject all or any part of the notice without assigning reason thereof. In case of unavoidable circumstances, if the Quotation could not be opened on the scheduled date, then next date will be communicated to the bidders as per decision of authority. Incomplete tender papers shall be liable for rejection.
4. GST Registration Certificate: The intending bidder should submit the photocopy of the GST registration Certificate & Number. PAN card with original bid document.
5. The intending bidder should submit a self declaration that the bidder has not been blacklisted by any Govt. organization.
6. Price: price quoted by the bidder should include all charges such as GST, Transportation charges, installation charges or any other charges. Any increase in the rates during time of supply is not permissible.

EMD: The intending bidder should submit the EMD of Rs. 5000/- in shape of bank draft drawn in favor of "District Child Protection Officer, Kandhamal" payable at SBI, Phulbani along with bid documents.
