Supply the detailed information.	<p>The RI, Phulbani submit "G" memo and reported that Sri Simanchala Behera (Secretary, Shree Shree Radha Krishna Temple), S/O- Pabitra Behera, AT- Kumbharapada, PO: Phulbani, Dist- Kandhamal has encroached the Government land bearing Plot No. 866, Khata No. 860 (Anabadi) of Mouza: Ollenbatch Nagar by constructing Shree Shree Radha Krishna Temple.</p> <p>Encroachment case was instituted bearing No. 4-8/2025 under OPLE Act 1972 was initiated for encroachment of Government land and illegal construction of Shree Shree Radha Krushna Temple over plot No. 866, Khata No. 860 (Anabadi) against Sri Simanchala Behera (Secretary, Shree Shree Radha Krishna Temple), S/O- Pabitra Behera, AT- Kumbharapada, PO: Phulbani, Dist- Kandhamal</p> <p>The Opposite Party No. 5 (Secretary, Shree Shree Radha Krishna Temple) has been noticed to submit the show cause on dated 12.02.2025 prior to this construction work has already been stopped by issuing form "Ga" as per Rule 8 of OPLE Act-1972 vide PR No. 454 Dated 13.03.2025.</p>

ORDER

WHEREAS, WP (C) No. 28570/2024 was filed by Mohan Behera -vrs.- State of Odisha and others with prayer to evict the illegal construction of the temple over the pani nala.

WHEREAS, the Hon'ble High Court, Orissa has disposed the Writ in Order Dtd.25.11.2024 in WP (C) No. 28570 of 2024 with a direction to the O.P No. 4 to "to look into the grievance of the Petitioner as per his representation dated 30.09.2024 under Annexure-6 and dispose of the same, in accordance with law, within a period of four months from the date of receipt of a certified copy of this order along with a copy of the writ petition."


WHEREAS, Sri Mohan Behera, Petitioner and Sri Santosh Kumar Padhi opponent was called for to attend hearing on 18.12.2024 vide this office P.R No. 2028 Dated.11.12.2024 & PR No. 2027 Dated 11.12.2024 respectively. In response to the aforementioned notices. Sri Mohan Behera was present. However, Sri Santosh Kumar Padhi had filed time petition stating that Secretary and President were of headquarter and he was busy otherwise on 18.12.2025. Sri Mohan Behera stated that "Opposite Party No. 5 & 6 has encroached the Government of Land and obstructing the old pani Nala by constructing Shree Shree Radha Krishna Temple. Further on 23.12.2024 Sri Santosh Kumar Padhi was present on behalf of Secretary, Radha Krishna Temple and stated that they had applied for lease of the plot in which the construction work is being done and claimed that there was no encroachment in any Pani nalla.

WHEREAS, on verification of records it was found that lease had been applied for plot No. 862 which is of "Patita" kisam.

Now therefore keeping view of the present circumstances, issue direction to RI, Phulbani to verify the fact on field and submit "G" form against the encroacher, if any encroachment is found. DA, OPLE is directed to initiate encroachment proceeding if "G" form would be submitted by RI. Secretary, Radha Krishna Temple is hereby directed to stop construction until finalization of lease. DA, Alienation to issue notice.

The petition of Sri Mohan Behera hereby stands disposed.

Intimate the matter to the Hon'ble High Court, Orissa accordingly.




