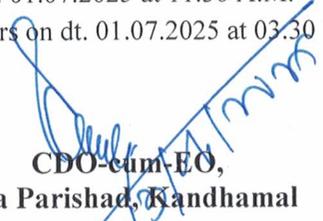

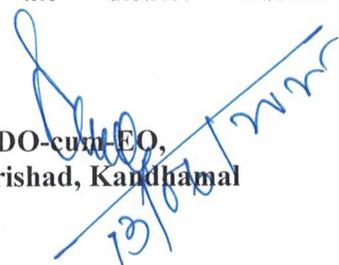

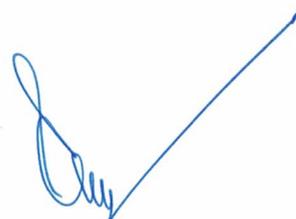

## SCOPE OF WORK AND GENERAL INSTRUCTION FOR BIDDERS

1. The Zilla Parishad, Kandhamal requires the services of reputed, well established and financially sound Manpower Service Providers to provide services of **1 No. of DPC for Z.P. Office, 01 No. of DPE for Z.P. Office, 01 No. of CCE for Z.P. Office, 12 No. of BPCs @ 1 No. per Block and 12 No. of BPAs @ 1 per Block** on outsourcing basis for day to day official work under Rural Housing.
2. The contract for providing the aforesaid manpower is likely to commence after selection of the service provider by the selection committee and would ordinarily continue for a period of **09 month** of the financial year 2025-26 from the date of execution of agreement. The contract of Service Provider Firm may be extended or curtailed subject to requirement and satisfactory performance by the Firm. The Z.P., Kandhamal, however, reserves the right to terminate this initial contract at any time after giving **one month's** notice to the selected Service Provider.
3. The tentative requirement is of **27 (Twenty-Seven numbers of DPC/DPE/CCE/BPC/BPA)**. This includes 01 DPC, 01 DPE, 01 CCE, 12 BPC and 12 BPA. The requirement may increase or decrease in any / all the categories as per requirement.
4. The estimated cost of the contract is Rs.50,53,050/- (Rupees fifty lakh fifty-three thousand fifty) only.
5. The tender document can be downloaded from the official web site of NIC, Kandhamal i.e. [www.kandhamal.nic.in](http://www.kandhamal.nic.in). The cost of tender paper is Rs.2,360/- (Rupees two thousand three hundred sixty) only, including GST 18% in shape of an Account Payee DD in favour of C.D.O.-cum-Executive Officer, Z.P., Kandhamal and payable at Phulbani.
6. 7. The various crucial dates relating to **"Tender for providing Manpower Services to the Zilla Parishad, Kandhamal, Phulbani** are as below.

8. The sealed tender has been invited under **two bid system i.e. Technical Bid and Financial Bid**. The interested agencies are advised to submit two separate sealed envelopes super scribing **"Technical Bid for providing Manpower Services to Zilla Parishad, Kandhamal"** and **"Financial Bid for Providing Manpower Services to Zilla Parishad, Kandhamal**. Both sealed envelopes should be kept in a third sealed envelope super scribing **" Proposal for Providing Manpower Services to Zilla Parishad, Kandhamal under Rural Housing Schemes"**.
9. The Earnest Money Deposit (EMD) of Rs.1,00,000/- (Rupees one lakh only), refundable (without interest), should be necessarily accompanied with the Technical Bid of the service provider in the form of Demand Draft drawn in favour of C.D.O.-cum-Executive Officer, Kandhamal payable at Phulbani **failing which the tender shall be rejected summarily.**

10. The successful tenderer will have to deposit a Performance Security Deposit of Rs.2,00,000/- (Rupees two lakhs only) in the form of Fixed Deposit Receipt (FDR)/Demand Draft from any Nationalized Bank drawn in favour of **C.D.O.-cum-Executive Officer, Z.P., Kandhamal payable at Phulbani** covering the period of contract, within **seven days** on signing of the agreement. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be renewed accordingly by the successful tenderer.
11. The tendering manpower service providers are required to enclose self-attested photocopies of the documents mentioned on **page no. 12** along with the Technical Bid. Failure to do so shall result in summary rejection of their bids, which will not be considered further.
12. **The conditional bids shall not be considered and will be out rightly rejected in very first instance.**
13. **The Blacklisted bidder shall out rightly be rejected.**
14. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. **No overwriting or correction is permitted in the Financial Bid Form. In such cases, the tender shall be liable for rejection.** However, correction, if any, in the Technical Bid Application must be initiated by the person authorized to sign the tender bids.
15. The Technical bids shall be opened on the scheduled date and time i.e. at **11:00 A.M** on **dt. 01.07.2025** in the office chamber of the C.D.O.-cum-Executive Officer, Z.P., Kandhamal, in the presence of the Manpower Service Provider or their authorized representatives, and anyone who wishes to be present on the spot at that time.
16. The Financial Bid of only those tenderers will be opened whose Technical Bids are found in order. The Financial Bids shall be opened at **3.30 PM** on **dt. 01.07.2025** in the office of C.D.O.-cum-Executive Officer, Z.P. Kandhamal in the presence of the bidders or their authorized representatives, and anyone who wishes to be present on the spot at that time.
17. At any time prior to the last date for receipt of bids, CDO-Cum-EO, Zilla Parishad, Kandhamal on behalf of PR & DW Department may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Tender document by a corrigendum.
18. The corrigendum (if any) & clarifications to the queries from all bidders will be posted on district administration website.
19. Any such corrigendum shall be deemed to be incorporated into this Tender.
20. In order to provide prospective Bidders reasonable time for taking the corrigendum into account, CDO-cum EO, Zilla Parishad, Kandhamal on behalf of PR & DW Department may, at its discretion, extend the last date for the receipt of Proposals.
17. The **CDO-cum-EO, ZP, Kandhamal** reserves the right to annul all bids without assigning any reasons thereof.

## TECHNICAL REQUIREMENTS FOR THE TENDERING MANPOWER

### SERVICE PROVIDER

1. The tendering manpower service provider should fulfill the following technical specifications:
  - a. The registered office or one of the branch offices of the manpower service provider should be located within the jurisdiction of the user Z.P., Kandhamal Office. Besides, if the Z.P., Kandhamal/Head of Z.P., Kandhamal/Controlling Officer are procuring manpower for deployment in their filed office (s), the manpower service provider should provide the name, designation and contact number of the person to liaise with the said Field Office (s).
  - b. They should be registered under Indian Companies Act; 1995(Now CA-2009) or Limited Liability Partnership Act 2008.
  - c. The Start-UP India Certified Company will be given preference.
  - d. They should have more than **three years'** experience in providing manpower to Government Departments/Public Sector/Private Companies as on last date of submission of Bid.
  - e. The bidder must be a CMM/ISO 9001/IEC 20000 certified company. For startups, certification and recognition by DPIIT under Startup India are required.
  - f. They should have their own Bank Account.
  - g. They should be registered under Odisha Goods and Services Act, 2017.
  - h. They should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance etc.
  - i. They should have any other regulatory clearance (to be specified by the user Z.P., Kandhamal) that may be required for providing man power services.
  - j. The Minimum annual turn-over of the company shall at least be 5 times of the present contract value (**The average annual turnover for the last 3 financial years will be calculated**).
  - k. The Start-UP certified company will be exemption on turnover Rs.10,00,000/- (Rupees Ten Lakh only)
  - l. The agency should fulfill all the statutory compliance of Finance Department, Government of Odisha as stipulated from time to time. The rate quoted by the firm should be adequate enough to cover all the statutory dues of Government.
  - m. The selected firm is liable to comply with all the terms and conditions stipulated by Government from time to time during the agreement in force.
  - n. In case two or more bidders quote the same price, the committee shall adopt an appropriate and transparent evaluation procedure to determine the LI bidder.
  - o. The sealed tender shall be of two bids system i.e. Technical Bid and Financial Bid. The interested agencies are advised to submit two separate sealed envelopes super scribing "**Technical Bid for providing Manpower Services to Zilla Parishad, Kandhamal**" and "**Financial Bid for Providing Manpower Services to Zilla Parishad, Kandhamal.**" Both these sealed envelopes should be kept in a third sealed envelope super scribing "**Proposal for Providing Manpower Services to Zilla Parishad, Kandhamal under Rural Housing Schemes.**"
  - p. The Black listed Firm(s) shall out rightly be rejected. An undertaking shall be furnished by the bidder stating that their firm(s) have not been blacklisted in any district.



**TECHNICAL REQUIREMENTS FOR MANPOWER TO BE DEPLOYED BY THE  
SUCCESSFUL MANPOWER SERVICE PROVIDER IN THE ZILLA PARISHAD,  
KANDHAMAL**

1. He/ She should be above 18 years of age as on the date of agreement.
2. The candidate shall have functional knowledge of computers and be well versed in MS Office Software and internet. He should also be proficient in other standard packages and applications.
3. The candidate shall have working knowledge of English and Odia on computer.
4. The candidates nominated by the qualifying firm shall be ready to report for work immediately after deployment by Z.P.
5. The candidates should be well conversant with computers and essentially well trained in MS office, internet and LAN function.

## TERMS & CONDITIONS

### GENERAL

1. The Agreement shall commence from ..... and shall continue till..... **(Nine Month)** unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirements.
2. The Agreement shall automatically expire on dated ..... unless extended further by the mutual consent of the Manpower Service Provider and the Authority.
3. The Agreement may be extended, on the same terms and condition or with some additions/deletions/modification, for a further specific period mutually agreed upon by the Manpower Service Provider and the Authority.
4. The Manpower Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this Agreement to any other agency or organization by whatever name be called without the prior written consent of the Authority.
5. The DRDA, Kandhamal, at present, has tentative requirement of **(1) One DPC, (1) One DPE, (1) One CCE for Z.P. Office, (12) Twelve nos. of BPC @ 1no. each block and (12) Twelve nos. of BPC @ 1no. each block** on urgent basis. The requirement of the Z.P., Kandhamal, may further increase or decrease marginally, during the period of initial contract also and the bidder would have to provide additional manpower, if required on the same terms and condition.
6. The Manpower Service Provider will be bound by the terms and conditions as furnished by it to the Authority while submitting the tender or at any subsequent stage. In case, any of such documents furnished by it is found to be false at any stage, it would be deemed to be breach of terms of Agreement making it liable for legal action besides termination of the Agreement.
7. The Authority reserves the right to terminate the Agreement at any time after **giving 15 days'** notice to the Manpower service provider.
8. The manpower service provider will have to deploy manpower within **seven days** of signing the agreement.
9. The person deployed shall be required to report for work at 10.00 AM in the office of the Block Development Officers as may have been kept in charge of the Office Establishment of the Office concerned and would leave at 12.30 PM. and may also require to work beyond 12.30 PM for which he would not be paid any extra remuneration for additional work as and when required. In case, the person deployed remains absent on a particular day or comes late / leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.
10. The Manpower Service Provider shall nominate a coordinator who shall be responsible for immediate interaction with the Z.P., Kandhamal, so that optimal services of the persons deployed could be availed without any disruption.
11. The entire, financial liability in respect of manpower service deploy in Block offices shall be that of the Manpower Service Provider and the Block office concerned will in no way be liable for any lapses. It will be the responsibility of the Manpower Service Provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidence as may be required by the Z.P., Kandhamal or Office concerned for reimbursement of Bill of the firm for the succeeding month. If at any point of time it is noticed that the agency paying lesser remuneration to the candidates than the rate quoted, then the agreement shall be terminated and EMD & security etc. deposits shall be forfeited forthwith.
12. The payment of remuneration to the manpower has to be through bank account only. No cash payment can be made to them.

13. For all intents and purposes, the Manpower Service Provider shall be "Employer" within the meaning of all applicable laws in respect of manpower so deployed. The person deployed by the Manpower Service firm shall not have any claim whatsoever like employer and employee relationship against the Z.P., Kandhamal or any office concerned.
14. The Manpower Service Provider shall be solely responsible for the redressal of grievance or resolution of disputes relating to person deployed. The Z.P., Kandhamal, Phulbani shall, in no way, be responsible for settlement of such issues whatsoever. In case the grievances of the deployed person are not attended to be the Manpower Service Provider the deployed person can place their grievance before a Joint Committee consisting of a representative of the Z.P., Kandhamal or office concerned and an Authorized representative of the Manpower Service Provider.
15. The Z.P., Kandhamal shall not be responsible for any financial loss or any injury to any person deployed by the Manpower Service Provider in the course of their performing the functions/duties, or for payment towards any compensation.
16. The persons deployed by the Manpower Service Provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed employees during the currency or after expiry of the Agreement.
17. In case of termination of this Agreement in its expiry or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and shall have no claim whatsoever for any absorption in regular or other capacity in Z.P., Kandhamal or any offices attached to him/her.
18. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with office under any provision of rules and Acts. Undertaking from the person deployed to this effect shall be required to be submitted by the Manpower Service Provider.
19. The Manpower Service Provider must be registered with the concerned Govt. Authorities, i.e. Labour Commissioner, Provident Fund Authorities, Employment State Insurance Corporation etc. and a copy of the same shall be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining License under Contract Labour (Regulation and Abolition) Act., 1970 if any, at his own part and cost.
20. The Manpower Service Provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the Manpower Service Provider. The Manpower Service Provider shall be responsible for contributions towards Provident Fund and Employees State Insurance, wherever applicable.
21. The Person deployed by the Manpower Service should have good police records and no criminal case should be pending against them.
22. The person deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the Z.P., Kandhamal or office concerned. The Manpower Service Provider shall be responsible for any act of indiscipline on the part of the person deployed.

#### **LEGAL**

23. The persons deployed shall, during the course of their work be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take oath of confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person deployed liable for penal action under the applicable laws, besides action for breach of contract.
24. The Manpower Service Provider shall be responsible for compliance of all statutory provisions relating to minimum wages payable to different types of worker in respect of the persons deployed by it in the Z.P., Kandhamal or office concerned shall have no liability in this regard.

25. The Manpower Service Provider shall be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the Z.P., Kandhamal or office concerned tax collection authorities, from time to time, as per the rules and regulations in the matter. Self-Attested photo copies of such documents shall be furnished to the Z.P., Kandhamal.
26. The Manpower Service Provider shall maintain all statutory registers under the Law and shall produce the same, on demand, to the authority of the Z.P., Kandhamal or office concerned or any other authority under Law.
27. The Tax deduction at source (TDS) shall be done as per the provision of Income Tax Act/Rules, as amended, from time to time and certificate to this effect shall be provided by the office concerned.
28. In case, the Manpower Service Provider fails to comply with any liability under appropriate Law and as result thereof, the Z.P., Kandhamal or the office concerned is put to any loss / obligation, monetary or otherwise, the Z.P., Kandhamal or the office concerned will be entailed to get itself reimbursed out of the outstanding bills or the performance Security Deposit of the Manpower Service Provider, to the extent to the loss or obligation in monetary terms.
29. Agreement is liable to be terminated because of non-performance, deviation of terms and condition of contract, non-payment of remuneration of employed persons and non-payment of statutory dues or for any other reason. The Z.P., Kandhamal or office concerned will have no liability towards non-payment of remuneration to the persons employed by the Manpower Service Provider and the outstanding statutory dues of the service provider to statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the Z.P., Kandhamal or office concerned by the person deployed, the same shall be recovered, the same shall be recovered from the unpaid bills or adjusted from the performance Security Deposit.

## FINANCIAL

30. The Technical Bid should be accompanied with an Earnest Money Deposit (EMD) of (refundable without interest) Rs.1,00,000/- (Rupees one lakh) only in the form of Demand Draft drawn in favour of C.D.O.-cum-Executive Officer, Z.P., Kandhamal payable at Phulbani **failing which the tender of the concerned agencies/firms shall be rejected out rightly.**
31. The Earnest Money Deposit in respect of agencies/firms which do not qualify the technical Bid (first stage) or Financial Bid (Second competitive stage) shall be returned to them without any interest. **In case of successful tender, if the agency fails to deploy the required manpower against the initial requirement within 30 days from date of placing the order, the EMD shall stand forfeited without giving any further notice.**
32. The successful bidder shall have to deposit a Security Deposit of Rs. 2,00,000/- (Rupees two lakhs) only in the form of Fixed Deposit Receipt (FDR) issued in favour of C.D.O.-cum-Executive Officer, Z.P., Kandhamal payable at Phulbani covering the period of contract within **seven days** of signing of the agreement. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be renewed accordingly by the successful bidder.
33. In case of breach of any terms and condition attached to this agreement the performance Security Deposit of the Manpower Service Provider shall be liable to be forfeited besides annulment of the Agreement.
34. The Manpower Service Provider shall raise the bill, in triplicate, along with attendance sheets in respect of the persons deployed and submit the same to the prescribed authority of the concerned offices in the first week of the succeeding month. As far as possible the payment will be released by the second week of the succeeding month.

35. The claim in bills regarding Employees State Insurance, provident fund and Service Tax etc. should be necessarily accompanied with documentary proof pertaining to the concerned bill of month. A requisite portion of the bill or whole of the bill amount shall be held up till such proof is furnished, at the discretion of the Z.P., Kandhamal or office concerned.
36. The amount of penalty calculated @Rs.100 per day on account of delay. If any, providing a suitable substitute for the period beyond three working days by Manpower Service Provider shall be deducted from monthly bills in the succeeding month.
37. The Authority reserves the right to withdraw or relax any of the terms and condition mentioned above so as to overcome the problem encountered at a later stage.
38. In the event of any dispute arising in respect of the clauses of the agreement the same shall be resolved through negotiation. Alternatively, the dispute shall be referred to the next higher Authority or controlling officer for his decision and the same shall be binding on all parties.
39. All disputes shall be under the jurisdiction of the District Civil court located at Phulbani in the District of Kandhamal.
40. The successful bidder will enter into an agreement with the Collector-cum-CEO, ZP, Kandhamal for supply of suitable and qualified manpower as per requirement of the Z.P., Kandhamal on the above terms and conditions.

4. The Man power Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this agreement to any other agency or organization by whatever name be called without the prior consent of the Authority.
5. The Manpower Service Provider will be bound by the details furnished by it to the Authority while submitting the tender or at subsequent stage. In case, any of such documents furnished by it is found to be false at any stage, it would be deemed to be breach of terms of Agreement making it liable for legal action besides termination of the Agreement.
6. The Authority reserves the right to terminate the Agreement during initial period also after giving 15 days' notice to the Manpower Service Provider.
7. The persons deployed shall be required to report for work at 10.00 AM to the ..... (Name of office) as may have been kept in charge of the Office Establishment of the office concerned and would leave at 5.30 P.M. for which he would not be paid any extra remuneration. In case, the person deployed remains absent on a particular day or comes late/leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.
8. The Man power service Provider shall nominate a coordinator who shall be responsible for immediate interaction with the Authority so that optimal services of the persons deployed could be availed without any disruption.
9. The entire financial liability in respect of manpower services deployed in the office shall be that of the Manpower Service Provider and this office will in no way be liable. It will be the responsibility of the Manpower Service Provider to pay the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidence as may be required by the office.

15. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with this office under provision of rules and Acts. Undertaking from the person deployed to this office shall be required to be submitted by the Manpower Service Provider.
16. The Manpower Service Provider must be registered with concerned Government Authorities, i.e. Labour Commissioner, Provident Fund Authorities, Employees State Insurance Corporation etc., and a copy of the registration should be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining license under contract Labour (Regulations and abolition) Act, 1970 if any, at his own part of cost, if required under the act.

The payment in respect of the overlapping period of the substitute shall be the responsibility of the Manpower Service Provider.
