



## TENDER DOCUMENT

In pursuance of the approved Action Plan of afforestation programme for the year 2025-26 in Phulbani Forest Division it is required to procure 07 MT NPK (20-20-20) for use in plantation sites of different Forest Range of this Division under CAMPA & IGC schemes.

### Eligibility of person to submit tender :-

1. The invitation to participate in the Tender is open to all who manufactures and sells above materials of approved quality.
2. The Tender shall be submitted in off line mode in two parts namely Technical Bid & Financial Bid. **Separate Bid for different items shall be submitted.**
3. Interested person/agency shall download detail tender application from the NIC website (<http://kandhamal.odisha.gov.in>) and shall be submitted in sealed covers i.e. one for Technical Bid and other is Financial Bid clearly mentioned in the covers.
4. For participation in the tender, participation fee of Rs.1180/- in shape of Demand Draft purchased in favour of DFO, Phulbani Forest Division in any Nationalised bank which shall be attached in the Technical bid of the tender paper and participation fee is non-refundable.
5. Separate bid for different materials as mentioned above shall be submitted.
6. Besides participation fees, the Tenderer has to attach EMD of Rs.10000/- (Rupees Ten Thousands) only in shape of Demand Draft in favour of DFO, Phulbani, which shall be refunded to un-successful tenderers immediately after closure of tender.
7. The supplier must not have been banned or black listed by any Government organization.
8. There must not be any adverse action pending against the supplier on the quality of the product.
9. The supplier must have valid GST Registration, PAN and Tax clearance certificate up-to 31.3.2025.
10. The Self Help Group (SHG) producing Organic NPK are also eligible to participate in the tender. The SHG group has to deposit Rs.1180/- in shape of Demand draft in favour of DFO, Phulbani Forest Division to participate in the Tender.

### Terms & Conditions

1. The Tender shall be submitted in two sealed cover i.e. One Technical Bid and the other is Financial Bid. The item for which the Tender is submitted should be clearly superscribed on the Bid Seal Cover.
2. The successful tenderer shall also furnish a security deposit @1% of the total bid amount duly pledged in favour of the Division Forest Officer, Phulbani Forest Division in shape of Demand draft only drawn on any nationalized bank at Phulbani. This Security deposit shall be returned after complete delivery of the materials.
3. The tenderer or his authorized representative shall **produce sample of their material before the tender selection committee.**
4. The Technical bid/Financial Bid shall be opened on 21.7.2025. Financial Bid shall be opened after approval of Technical Bid.
5. **Selection of the material shall be based solely on quality of the produce submitted by the bidder in sample packet and evaluated by the Tender Selection Committee.**
6. The bidder shall submit an undertaking to the effect that if selected, the material supplied by the bidder shall be of same quality as produced before the Tender Selection committee as sample packet, failure in adhering to this condition, the supply order issued by the authority shall be cancelled and EMD shall be forfeited to State.
7. The cost of material furnished in the bid document shall be inclusive of transportation Charges and Taxes admissible if any.
8. All payments to the Tenderer shall be made after completion of delivery of approved quality of materias after adjusting the EMD and Security Deposit.
9. The materials shall strictly confirms to the specification of NPK (20-20-20) as per FCO.
10. All documents and Original Tender paper should be signed by the Tenderer with date.
