Due to the non receipt of tender paper invited by this office Notice No. 2411/Dated. 14.07.2025 again a Sealed quotations/Tenders are invited from interested reputed Travel Agencies/Tour Operators of individuals for providing one numbers of Maruti Swift Dzire Petrol driven vehicles having sitting capacity not more than five including driver, which shall conform to the terms and conditions (Appendix-A) for official use in District Social Welfare Officer, Kandhamal, Phulbani, for Hub empowerment of Women on monthly rent basis

1. The service provider shall have a valid GST registration to participate in the tendering.
2. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certification/Valid Contract Carriage Permit, proof of up to date tax payment etc, mandatory for plying of vehicle.
3. The Driver of the vehicle must have valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The Driver should be well behaved, gentle and obedient in nature.
5. The hired vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays.
6. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour DSWO, Kandhamal and submitted along with the tender as EMD. After completion of tender process, the amount will be refunded to unsuccessful bidders.
7. The monthly rate of hire charges is quoted separately in the general bid information (Excluding fuel and Lubricants). The maximum hire charges including GST per month excluding petrol cost **Rs. 24,000/-**.
8. The vehicle must achieve a fuel efficiency of 17 Kms per liter.
9. The details of the make and year of manufacture of the vehicle, registration number, mileage (Kms covered per liter) and name of the Driver with Driving License number and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure-B).
10. The Quotation completed in all respect should reach the undersigned on or before dtd. **24.07.2025** by **5.30 P.M** through speed post/Registered/Courier and shall be open on the day **25.07.2025** at **11 A.M** in the presence of the bidder or authorized representatives.
