





Govt. of Odisha has introduced e-payment gateway in to the portal for payment of cost of Bid and Bid Security / Earnest money Deposit .The process of using e-payment gateway is mentioned in the “ Procedure for electronic receipt ,accounting & reporting of cost of Tender paper & EMD in submission of Bids” of DTCN.
4. The Bid documents will be available in the www.tendersodisha.gov.in.from 1.00 PM of **14.07.2025 to 5.00 PM of 21.07.2025** Online Bidding.
5. The Bidder must possess Compatible Digital Signature Certificate (**DSC**).
6. Bids shall be received only “**on line**” on or before **5.00 PM of 21.07.2025**.
7. Bids received on “on line” will be **opened at 11.30 AM on Dt. 22.07.2025**. in the office of the Executive Officer, NAC, Balliguda in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day.
8. The cost of bid documents mentioned under col. 5 above are to be remitted online through a process as mentioned in the DTCN.
9. Detailed information as contained in the DTCN shall have to be strictly adhered to while submitting the tender.
10. Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to this effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which the tender is being submitted must be mentioned in the affidavit.
11. Any tenderer desirous to avail any facility as per certain circular /orders of Govt. have to apply for the same in writing along with tender paper, claim at the time of opening of tenders or latter will not be entertained.
12. Any Corrigendum /Addendum will be displayed in the website [www. Orissa. Govt. in](http://www.Orissa.Govt.in) & [https. // tenders.ori.nic.in](https://tenders.ori.nic.in).
13. Additional performance security shall be obtained as per office memorandum No. 4559/Dated 05.04.2021 of Works Department, Govt. of Odisha in shape of Demand Draft / Term Deposit Receipt pledge in favour of the Executive Officer, NAC, Balliguda within seven days otherwise the bid shall be cancelled and the security deposit will be forfeited. Further proceeding for blacklisting will be initiated against bidder.
14. Other details can be seen in the bidding documents. The authority will not be held responsible for any technical problem /failure of network /server during the schedule dates of online binding.
15. The rate is inclusive of GST.
16. The Bidders are requested to furnish the Email ID & Phone No. along with the tender.
17. If after opening of the tender, it is seen that, the tender has to be decided through a transparent lottery system then the lottery date will be intimated through email, Whats App No. and speed post. The lottery will be held even if no bidder remains present.
18. The tenderer must have to accompany copies of his/her valid License, valid PAN, valid GST


and Affidavit etc. relevant documents during online submission of bid.


