TENDER DOCUMENT

In pursuance of the approved Action Plan of afforestation programme for the year 2025-26 in Phulbani Forest Division it is required to procure **01(One) MT Deoiled Neem Cake Power** for use in plantation sites of different Forest Range of this Division under CAMPA & IGC schemes.

Eligibility of person to submit tender for De-oiled Neem Cake Power :-

1. The invitation to participate in the Tender is open to all who produces and sells organic pesticide of approved quality with production unit **within the State of Odisha**.
2. Interested person/agency shall download detail tender application from the NIC website (<http://kandhamal.odisha.gov.in>) and shall be submitted in sealed covers i.e. one for Technical Bid and other is Financial Bid clearly mentioned in the covers.
3. For participation in the tender, Non-refundable participation fee of Rs.1180/- in shape of Demand Draft purchased in favour of DFO, Phulbani Forest Division in any Nationalised bank which shall be attached in the Technical bid of the tender paper and participation fee is non-refundable.
4. Besides participation fees, the Tenderer has to attach EMD of Rs.10000/- (Rupees Ten Thousands) only in shape of Demand Draft in favour of DFO, Phulbani, which shall be refunded to un-successful tenderers immediately after closure of tender.
5. The supplier must not have been banned or black listed by any Government organization.
6. There must not be any adverse action pending against the supplier on the quality of the product.
7. The supplier must have valid GST Registration, PAN and Tax clearance certificate up-to 31.3.2025.
8. The Self Help Group (SHG) producing Neem Cake are also eligible to participate in the tender. The SHG group has to deposit Rs.1180/- in shape of Demand draft in favour of DFO, Phulbani Forest Division to participate in the Tender.
9. The quality of the pesticide shall confirm to the specification prescribed in of FCO-1985.

Terms & Conditions

1. The Tender shall be submitted in two sealed cover i.e. One Technical Bid and the other is Financial Bid. The item for which the Tender is submitted should be clearly **superscribed** on the Bid Seal Cover.
2. The successful tenderer shall also furnish a security deposit @1% of the total bid amount duly pledged in favour of the Division Forest Officer, Phulbani Forest Division in shape of Demand draft only drawn on any nationalized bank at Phulbani. This Security deposit shall be returned after complete delivery of the materials.
3. The tenderer or his authorized representative shall **produce sample of their material before the tender selection committee.**
4. The Technical bid/Financial Bid shall be opened on **21.7.2025**. Financial Bid shall be opened after approval of Technical Bid.
5. **Selection of the material shall be based solely on quality of the produce submitted by the bidder in sample packet and evaluated by the Tender Selection Committee.**
6. The bidder shall submit an undertaking to the effect that if selected, the material supplied by the bidder shall be of same quality as produced before the Tender Selection committee as sample packet, failure in adhering to this condition, the supply order issued by the authority shall be cancelled and EMD shall be forefeited to State.
7. The cost of material furnished in the bid document shall be inclusive of transportation Charges ,unloading and Taxes admissible if any.
8. All payments to the Tenderer shall be made after completion of delivery of approved quality of Neem Cake after adjusting the EMD and Security Deposit.
9. All documents and Original Tender paper should be signed by the Tenderer with date.
10. **The Decision of the Tender Selection Committee of Phulbani Forest Division shall be final & binding.**
11. **The product of the bidder shall confirm to the Specification of the Deoiled Neem Cake power as mentioned in FCO-1985 and the tenderer has to attach a signed certificate along with original tender document the enclosed format .**

Additional Terms & conditions

1. The Purchaser reserves the right to increase or decrease the quantity to be ordered upto 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up-to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Delivery and unloading is to be done at Range Headquarters of Phulbani Forest Division

3. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

Mandatory Additional Terms and conditions

4. **The bidder shall have production Centre/ factory within State of Odisha.** GPS coordinates of the production Centre/ factory shall be provided in the bid for physical verification of the production Centre/ factory by the technical team of the Division. The team shall also verify the quality as the Specification for Neem Cake as per FCO, 1985 mentioned above.

5. The production Centre/ factory for L1, L2, L3 bidder shall be verified.

6. Order shall be placed to any of the L1, L2, L3 bidder after physical verification of the quality and the production Centre/ factory of the firm by the technical team.

7. The rates quoted should be inclusive of loading and unloading , transportation charges at the Range Headquarters of Phulbani Forest Division.

8. Testing report as specified in the Fertilizer Control Order from ICAR Institutions / OUAT or any NABL accredited Laboratory.

9. Copies of GST return (Jan-Mar, 2025), Income Tax return ((AY 2025-26) along with copies of PAN and GST registration shall be submitted along with the technical BID.

10. The purchase order will be placed phase wise and subject to the feedback from the Range Officers.
