

QUOTATION CALL NOTICE

Sealed quotations are invited from the registered firms for refilling of Fire Extinguishers of DHH, Phulbani.

The suppliers have to submit their quotations in separate sealed covers which must be super-scribed as "Quotation for refilling of fire extinguishers of DHH, Phulbani".

1. Technical Bid Should contain as follows:

- a) The document should be *serially arranged* and should be securely tied and bound.
- b) Copies of organization PAN.
- c) Photocopy of the GST Registration Certificate.
- d) All the quotation documents should sign by the supplier at the bottom of each page with his official seal duly affixed.
- e) They should quote the rates for individual items inclusive of excise duty, insurance, packing, forwarding, freight (door delivery) and GST charges (if any).
- f) Eligible bidders should submit their quotation documents to the CDM & PHO, kandhamal through Speed Post/registered Post/ Courier on or before 03.12.2025 by 5:00 pm and will be opened on 04.12.2025 at 11.00 am.

2. Price Bid Should contain as follows:

- a) Financial Bid must be submitted in the prescribed format as attaché in Annexure-A. No other document should be enclosed in the Financial Bid.
- b) The rates should be computerized.
- c) The price quoted by the bidders shall not exceed the MRP.
- d) The price quoted by the bidders including all taxes.
- e) The last date for submission of the quotation documents is fixed on 03.12.2025 by 5.00 pm and will be opened on 04.12.2025 at 11.00 am by the purchase committee in presence of the bidders.



The undersigned reserves the right to reject or cancel any or all the quotations without assigning any reason thereof.




