## **TERMS AND CONDITIONS:-**

- 1 Sealed tenders will be received by Dated **07.01.2026 upto 5 pm** by the Nizarat Officer, Collectorate Office, Kandhamal, Phulbani. through Courier/Speed Post/ Regd. Post only (not by hand) for procurement of vehicle under PMTB Mukti Yojana. Any tender received after the due date & time will be rejected / returned to the sender unopened.
- 2 The bidder(s) are to submit their tender in sealed covered envelops for technical bid (Cover A) and price bid (Cover B). Both Cover A and Cover B should put into a third cover which should be super scribed as "**Tender for supply of vehicle for TB Patient under PMTB Mukti Yojana.**"
- 3 The Sealed tenders submitted by the bidders will be opened at Office Chamber of ADM, Kandhamal on date 08.01.2026 at 2.30 P.M. The tenderer or their only duly authorized representative is allowed to be present during the opening of the tenders if they so like.
- 4 No tender document(s) shall be accepted after the expiry of scheduled date and time for receipt of bids.
- 5 The details of items and specification (schedule of requirement) are mentioned at Annexure – I. The quantity to be procured may vary as per the demand / need.
- 6 Rate should be quoted only in Indian Currency (with paisa in two decimals only) in figures against each item as the payments will be made in Indian currencies only. The renderer shall not quote the rate for any item other than the item specified in the list.
- 7 The GST will be applicable as per the current guidelines issued by the Finance Dept., Govt. of Odisha from time to time.
- 8 Each page of the bid document shall be duly signed and self-attested by the bidder.

### **Tender Processing Fee and EMD:**

1. The tenderer shall deposit tender processing fees (non-refundable) amounting to Rs.1500/-only including GST 18% in shape of Demand Draft at any Nationalized Bank, in favour of Collector, Kandhamal Payable at Phulbani.
2. Bidders are required to deposit an EMD 2% of the bidding value @15,00,000 in shape of Bank Draft at any Nationalized Bank, in favor of Collector, Kandhamal Payable at Phulbani .EMD as per rule 212(i) of OGFR 2023 and vide MSME department notification no-566/MSME dt.24/01/2024.
3. The EMD of the responsive bidders will be kept as performance security till validity of rate contract and will be returned after successful

completion of rate contract. In case of non-responsive / un-successful bidders the EMD will be returned after completion / finalization of the tender process i.e. award of the rate contract. In no circumstances, the bidders will claim interest on the EMD deposited by him.

### **ELIGIBILITY CRITERIA:-**

Tenderers are eligible to participate in the tender, provided the following documents are submitted

- 1) Valid up-to-date TAX clearance certificate (Income Tax & GST).
- 2) **Annual Average Turnover of Rs 2 (Two) crore** in last two financial years.
- 3) Shall have PAN Card and GST registration.
- 4) Bidders who have been blacklisted either by the tender inviting authority or by any state government or PSU is not eligible to participate in this tender
- 5) In case of Private Limited firms they must submit Certificate of incorporation. In case of partnership firms, they submit the partnership deed registered with IGR.

### **DOCUMENTS SHOULD BE SUBMITTED WITH THE BID (COVER-A):-**

Earnest Money Deposit EMD 2% of the bidding value in shape of Bank Draft from any Nationalized Bank, in favor of Collector, Kandhamal & Tender Paper Cost Rs. **Rs. 1500/-**only. (including 18% GST) and the following documents must be enclosed :-

1. Copy of latest I.T Return & GST payment receipt
2. Copy of PAN CARD & GST registration certificate
3. List of items quoted along with product.
4. Price Bid in hard copy **signed & sealed** in each page properly.
5. Bidders contact details: name, address, telephone no., Fax, e-mail.
6. Declaration as per format on 10 Rupees Non judicial stamp paper.
7. Annual Turnover report.
8. The tenderer should submit/furnish a certificate in the tender to the effect that the price quoted by them is not more than the open market price.
9. Deviation of specification.
10. Bid Security Declaration Form as per format.

The tender format (Price Schedule) in the prescribed format hard copy must be submitted in the bid. The price of the item should be quoted inclusive of registration, insurance, packing, forwarding, freight (door

delivery) GST if any. The rate should be quoted in figures. Only two decimal points (paisa) will be taken into consideration ignoring the rest digits.

- i) The quoted rates should be final and shall not be subject to any escalation during the validity of the tender.
- ii) The tenderer should submit/furnish a certificate in the tender to the effect that the price quoted by them is not more than the open market price or also under GeM Rate Contract where such rate exists. However, in circumstances when the price decreases during the contract period, the approved supplier ethically, should intimate the same to the purchasing authority.

#### **REJECTION OF THE TENDER:**

The tender paper will be rejected, if any of the following documents are wanting / not submitted with the tender bid:

- i) Non submission of relevant documents as mentioned in Eligibility criteria.
- ii) Price bid / quoted rate without signature and seal

#### **EVALUATION:**

Tenders will be evaluated as per the requirement of the bid and the price bid will be opened only for the bidders who qualified in technical bid.

#### **PERFORMANCE SECURITY:**

The performance security is 5 % of the total accepted cost, which will be refund without interest after completion of the approval period.

#### **SUPPLY & DELIVERY:**

1. Delivery shall be made at CDM & PHO, Kandhamal.
2. Non-supply / unwilling to supply the ordered quantity will lead to forfeiture of EMD / performance security submitted by the supplier.
3. If the approved lowest eligible supplier fails to supply items in time, to meet the requirement the same shall be procured from the L2/ L3 suppliers at L1 rate, if they agree to supply at L1 approved rate.

## **Liquidated Damages:-**

If the successful Installation shall, without prejudice to other rights and remedies available to the Tender inviting Authority/ user institution under the contract, deduct from the contract price/ purchase order price as liquidated damages, a sum equivalent to 1% of the value of the item to be supplied per week of delay or part thereof on delayed supply of item (s) until actual delivery to maximum 4% reserves the right to allow an additional penal period of 4 weeks beyond the normal penal period on the written request of the supplier with the condition that liquidated damage @ 1.5% will be charged for each week or part thereof during the extended penal period. bidder fails to deliver any or all of the goods within the time frame (S) prescribed in the contract, the Tender Inviting Authority/User

## **GENERAL CONDITIONS:**

1. The tender documents should be clearly written /typed without any correction, interpolations and overwriting. Each page of the tender should bear the signature of the tenderer.
2. All copies of the tender document should be self-attested. If any information or documents furnished by the tenderer found to be misleading/incorrect at any stage, their tender will not be accepted.
3. If the last date of submission of bid being declared as a holiday for the purchaser's office, the due date submission of bids and opening of bids will be the following working date & time.
4. The quantum of procurement will be made on requirement basis.
5. The authority reserves the right to accept /reject all the bids or any part thereof without assigning any reason thereof.
6. Any legal disputes, relating to purchase etc. are subject to jurisdiction in the courts of law situated at Phulbani, Kandhamal.

**PAYMENT:**

- a. 100% payment shall be made after delivery of item as per specification of disbursement certificate(s) from the concerned authority and as per the availability of funds. Under no circumstances the supply should be interrupted as regards to payment.
- b. No advance payments towards cost of delivery of item will be made to the approved tenderer.
- c. No payment shall be made if the quality of the items supplied is not of a good quality.
