Division, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging in to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7) The items covered in **Clause No-122 of DTCN** for roads and building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
- 8) The bidder shall transfer online the cost of bid documents as shown in **column-7** above through a process as mentioned in DTCN.
- 9) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
