**1. Technical Bid should contain following documents**


- The documents should be serially arranged and should be securely tied and bound – **Annexure-A**

- Photocopy of GST Registration Certificate.
- All documents related to vehicle should submit and signed by the supplier/ Individual at the bottom of each page.
- TDS Will be applicable as per guideline.
- The Technical Bid should be **super scribed by Expression of Interest for engagement of vehicle of daily hire basis**

**2. Financial Bid should contain as follows-**

- Financial Bid should be submitted in the prescribed format as attached in **Annexure-B**. No other document should be enclosed in the Financial Bid.
- The rate should be computerized.
- The vehicle owner should bear all tax of vehicle including Driver cost
- The Financial Bid should be **super scribed by Expression of Interest (Financial Bid) for engagement of vehicle on daily hire basis**

Both Technical & Financial Bid covered with another envelop which should be **super scribed by Expression of Interest for engagement of vehicle on daily hire basis** and should be addressed in favour of “The Block Public Health Officer, Community Health Centre, At/Po- CHC, Phiringia, Dist. 


