Block Public Health Officer, CHC Phiringia invites sealed quotations from authorized firms having valid GST Registration for performing Pest Control & Anti Termite Treatment at CHC/ PHCs/ SCs under CHC Phiringia with up to date GST Tax Clearance Certificate through Regd. Post/ Speed Post/ Courier to the Block Public Health Officer, CHC Phiringia.

The suppliers have to submit their quotations in separate sealed covers which must be superscribed as “Quotation for Pest Control & Anti Termite Treatment at CHC/PHCs/ SCs under CHC Phiringia”.

1. Technical Bid should contain following documents

- The documents should be serially arranged and should be securely tied and bound.
- The Supplier or bidder should submit valid license having authorization for Pest Control & Anti Termite treatment.
- Photocopy of Organization PAN
- Photocopy of GST Registration Certificate.
- The bidder should submit GST clearance certificate of last quarter/ last three months
- All documents should sign by the supplier at the bottom of each page with official seal duly affixed.
- They should quote the rates for individual items inclusive of all taxes, excise duty, insurance, packing, forwarding, freight (door delivery) & GST Charges if any.
- The Technical Bid should be **super scribed by Quotation Call Notice (Technical Bid) for Pest Control & Anti Termite Treatment**

2. Financial Bid should contain as follows-

- Financial Bid should be submitted in the prescribed format as attach in **Annexure-A**. No other document should be enclosed in the Financial Bid.
- The rate should be computerized.
- The price quoted by the bidders shall not exceed the MRP.
- The price quoted by the bidders including all taxes excise duty, insurance, packing, forwarding, freight (door delivery) & GST Charges if any
- The Financial Bid should be **super scribed by Quotation Call Notice (Financial Bid) for Pest Control & Anti Termite Treatment**




