
SHORT QUOTATION CALL NOTICE

Sealed quotation are invited from the intending supplying Agencies for purchase & supply of installation of Fire Safety equipment i.e { two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min. } to reach **on or before** 30-12-2025 by 5.00 PM Through Speed post /Registered post/ Courier to the Office of the DSWO, Kandhamal, Phulbani). The sealed quotation will be **opened on** 31-12-2025 at 11.30 AM by the undersigned in his office in presence of the quotationers or their authorized agents and Dist. Level Purchase Committee constituted for the purpose.

Details regarding quotation papers, terms & conditions, can be downloaded from the District Website (www.kandhamal.nic.in). There shall be two stages of bidding -- Technical & Financial. Interested tenderer must submit their technical bid and financial bids in separate envelope superscribed as financial and technical bid respectively. These two envelopes must be placed in a third bigger envelope superscribed as "quotation bid for purchase & supply of Fire Safety equipment i.e { two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min. }" in Kandhamal District".

The tenders received beyond the scheduled date & time shall be rejected. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.




1. Sample Copy of { two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min. } for Anganwadi Workers as prescribed by in Govt. in W&CD Deptt. are attached herewith.
2. The Collector reserves the right to reduce/enhance the quantity or items stated above during indent taking into consideration of availability of funds for the purpose.
3. The cost of {two buckets (one Sand bucket and one water bucket) alongwith one fire blanket(size 6ft x 4ft) min. } should be inclusive of all taxes/GST (Including transportation charges & loading unloading till delivery At project office) within specified period.
4. The quality of the {two buckets (one Sand bucket and one water bucket) alongwith one fire blanket(size 6ft x 4ft) min. } should be in conformity with the specification mentioned. District level purchase committee constituted for the purpose will check the quality of the above item during the selection of quotation. The sample of selected quotation will be preserved to compare with the {two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min. } delivered at District.
5. The Committee will verify the sample and the lowest rate quoted and the quotation will be finalized taking into consideration both the rates quoted by the firm and quality of paper submitted by the quotationer. The decision of the purchase committee regarding selection of the firms will be final. Before going to financial Bid, the sample of all firms shall be sent to Asst. Fire Officer, Phulbani, Fire Station for quality checking i.e **(IS No.- 3808 : 1979 and IS No.- 2546 : 1974)** and the cost of quality testing shall be borne by the firm.
6. Incase of the disputes above the quality of the { two buckets (one Sand bucket and one water bucket) alongwith one fire blanket(size 6ft x 4ft) min.} supplied Collector will cause an enquiry and take suitable action including debarment against the supplier and the whole or part of the Security Deposit/EMD will be forfeited for irregular performance or breach of any term (s) and condition (s) of the quotation.
7. The quotations should deposit EMD of Rs. 50,000/- (Fifty thousand) only in shape of Demand Draft/NSC/Fixed Deposit duly pledged in favour of Dist. Social Welfare Officer, Kandhamal quotations without Earnest Money will be liable for rejection.
8. Earnest Money deposited by the successful quotationers will stand converted to security deposit, which will be refunded after completion of payment.
9. Earnest Money of unsuccessful quotations shall be refunded after finalization of the quotataion.
10. Payment shall be made against submission of bills on completion of delivery for {two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min.} as per the orders of the competent authority alongwith receipt of supply certificate from concerned CDPOs.

11. The Collector shall have the right to deduct any amount found recoverable towards inferior quality, loss and damage etc. from the bill for supply of {two buckets (one Sand bucket and one water bucket) alongwith one fire blanket(size 6ft x 4ft) min. }. The supplier for delay in payment of the bill shall not claim any interest. No advance payment will be made before supply.
12. Conditional quotation will not be accepted.
13. Intending Agency should submit the sample with quotaion to the district office. Without sample quotation will not be accepted.
14. The { two buckets (one Sand bucket and one water bucket) alongwith one fire blanket (size 6ft x 4ft) min.} should be delivered by the supplier/firm within10 days from the date of issue of supply orders failing which daily penalty of 2% of the billed amount will be charged every 7 days delay beyond the specified date of supply (Total 2198 AWCs)
15. There shall be two stages bidding:- Technical & Financial bidding.

The quotation shall accompany the following documents:

- a. Original quotation paper duly self-attested by the quotationers as token of acceptance of the terms and conditions.
- b. Self-attested copy of Income Tax clearance certificate for last 3 years (i.e. 2022-23, 2023-24 & 2024-25)
- c. Self-attested copy of Xerox copy of the registration certificate of the unit.
- d. Self attested Xerox copy of Pan, TAN and Aadhar Card.
- e. The Demand Draft/NSC/Fixed Deposit of 50,000/- (Rupees fifty thousand) only duly pledged in favour of DSWO, Kandhamal towards deposit of E.M.D.
- f. Self attested copy of up to date GST return.
