

NOTICE

Empanelment of Vendors for ITDA Phulbani for the Year 2025-26. In accordance with Letter No. 20818/SSD/ dated 07.10.2023 from the Commissioner-cum-Secretary, Government of Odisha, ST & SC Development Department, and subsequent Office notifications No. 3130 /dated: 05.12.2025, as well as the recommendation of the Selection Committee of ITDA, Phulbani constituted vide this office order No. 16 /dated 02.01.2026, the following vendors (listed in Annexure-A) have been provisionally empaneled for the financial year 2025-26. The empanelment is subject to the following terms and conditions:

1. The vendor is required to supply materials and labor as per the specifications and brand mentioned in the requisition provided by the Junior Engineer (JE) or Assistant Engineer (AE).
2. All materials must meet the quality specifications, and both skilled and unskilled labor must be provided to the satisfaction of the concerned authority.
3. The vendor must ensure the timely supply of both materials and labor without any delays, as per the specified requirements.
4. In the event that low-quality or substandard materials are supplied, the vendor will be blacklisted.
5. The supply of materials and labour should be conducted under the supervision and monitoring of the concerned JE or AE.
6. Materials and labour must be provided at the specified location as directed by the JE or AE. The vendor is entitled to claim transportation costs, which will be reimbursed as per the OPWD Code.
7. The empanelment does not guarantee any right to claim or supply materials or labor. Supplies will be determined solely based on requirement and suitability.
8. The vendor must submit appropriate invoices, bills, or vouchers that detail the transactions and include relevant tax details.
9. The cost of cement and MS rods will be paid as per the rates fixed by the ITDA Tender Committee, Kandhamal.
10. Vendors must engage labour as per the work requirements and submit a duly signed muster roll from the engaged laborers in the event of a labor license not being available.

11. Applicable Income Tax will be deducted from the vendor's payments in accordance with legal provisions.
12. Vendors are required to submit GST-compliant bills or invoices for the materials supplied, as per the rules.
13. The empanelment list is purely provisional and temporary in nature. The authority reserves the right to cancel, reject, or remove any vendor from the list without assigning any reason thereof.
14. The publication of the provisional list of selected vendors does not constitute any guarantee of mandatory award of departmental work.
15. The authority reserves the right to amend, add, or remove any terms and conditions, subject to government guidelines, as necessary.
