QUOTATION CALL NOTICE FOR SUPPLY OF FOOD FOR THE PARTICIPANTS OF 6 DAYS (3DAYS IN EACH PHASE) REFRESHER TRAINING OF ASHAS EPS HELD IN 4 SECTORS UNDER CHC PHIRINGIA (i.e at CHC PHIRINGIA, PHC NUAPADAR, PHC GOCHHAPADA & AH BALANDAPADA)

Block Public Health Officer, CHC Phiringia invites sealed quotations from the suppliers for supply of food for 6 days(3 days in each phase for 2 phase) sector level Refresher Training of ASHAs on EPS held in 4 sectors (CHC Phiringia, PHC Nuapadar, PHC Gochhapada& AH Balandapada).

The supplier has to submit their quotations in separate sealed cover for Technical Bid & Financial Bid and both are sealed in 1 cover which must be superscribed as Quotation for supply of food for 6 days sector level Refresher training of ASHAs on EPS.

Technical Bid should contain as follows:

1. The Document should be serially arranged and should be securely tied and bound.
2. Preference will be given to the supplier having GST Registration. If GST supplier is not available then selection of supplier will be made from the quotation received.
3. Copies of organization / supplier PAN& AADHAAR Card.
4. All the quotation documents should sign by the suppliers at the bottom of each pagewith his officially seal duly affixed.
5. They should quote the rates inclusive of all taxes, excise duty, insurance, packing, forwarding, freight (door delivery i.e the supplier should supply food at sector level training venue i.e CHC Phiringia, PHC Nuapadar, PHC Gochhapda, AH Balandapada) and GST charges (if any).
6. If single quotation is received then the decision of purchase committee should be final.
7. The supplier must supply hygienic food to the participants.
8. Financial Bid must be submitted in the prescribed format as attached in Annexure-A.
9. 1 % TDS will be deducted from the bill amount of supplier if PAN & AADHAAR of supplier is linked, 20% if PAN & AADHAAR is not linked.

Eligible bidders should submit their quotation documents to the Block Public Health Officer, Kandhamal through Speed Post/ Registered Post/ Courier on or before 07.02.2026 by 2 PM and will be opened on the same day i.e 07.02.2026 at 3 PM under the Chairmanship of Block Public Health Officer and the member of the purchase committee in the presence of the bidders or their authorized representatives. If the bidder or their authorized representatives are absent then there is no bar for opening & finalization of quotations.




