1 Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website “www.tendersodisha.gov.in.”

2 The bidder shall transfer online the cost of bid document, Earnest Money deposit/Bid Security of the amount specified for the work in the table col.4 & 5 above as part of its bid through a process as mentioned under DTCN.

3 **Tender Paper cost & EMD:** The cost of Tender Paper as indicated above shall be received online along with the bids as per guideline issued by Works Deptt. and the EMD for each work is required. The procedure of bid submission using electronic payment of Tender Paper Cost and EMD by the bidder may be referred in Works Deptt. O.M. No. 17254, Dt. 05.12.2017 & Works Deptt. O.M No.-4710/W Dt.12.04.2022 which have been added to the DTCN. Tenderers’ desiring to hire machineries or equipment’s from outside of the state has to furnish 2% of the amount put to tender as bid security.

4 The Bid documents will be available in the website: “www.tendersodisha.gov.in” from **10.00 AM of 26.03.2026 to 05.00 PM of 04.04.2026** for online bidding. Any addendum / corrigendum / cancellation of tender if any will be hosted in the website only can also be seen in the said website.

5 The bidder must possess compatible Digital Signature Certificate (DSC) of **Class-II or Class-III.**

6 Bids shall be received only on “on line” on or before by **5.00PM of 04.04.2026**

7 Bids received on line shall be opened at **11.00 AM on 06.04.2026** in the office of the Project Administrator, ITDA, Phulbani in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

8 Other details can be seen in the bidding documents.

9 The Bid documents consisting of Plans, Specifications, the schedule of Quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: **“www.tendersodisha.gov.in”**

10 The bidders shall have to upload the Contractor license, PAN, GSTIN and other documents as per DTCN during participation in the bid. Failing of which the bid will be summarily rejected.

11 Amendment to Codal & Contractual provisions at Appendix – IX, Clause – 36 of OPWD Code Vol.-II by inclusion of incremental Additional performance security (APS) system vide O.M. No. 07764600022025_173/W Dated: 03.01.2026 of Works Dept. Govt. of Odisha. The **Additional performance security (APS)** shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:

I. where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.

II. where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;

III. where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price:

IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.

V. The additional performance security shall be treated as part of the performance security.

VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document., If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of term Deposit Receipt pledged in favour of Project Administrator, ITDA, Phulbani / Bank Guarantee in favour of the Project Administrator, ITDA, Phulbani from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Phulbani within seven days of issue of Letter of Acceptance (LOA) by the Project Administrator, ITDA, Phulbani (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder. (Vide Office Memorandum No.14459/W dated 20.09.2018 of Works Department, Govt. of Odisha).

12 The bidder has to submit the Cost of Tender Paper as the amount specified for the work electronically as per Works Department Memo No. 17254, dt. 05.12.2017. The cost of EMD must be submitted the successful bidder at the time of Drawl of Agreement as per Works Department Memo No. 17254, Dt. 05.12.2017.

14. The bidder has to submit DTCN signed, Affidavit of Authenticity of documents, Bid Security Declaration, GSTIN Registration Certificate, PAN Card, valid Contractor Data Base Management System (CDMS) Registration Certificate, Work experience certificate (in Scheduled- D1 & D2 as mentioned in the DTCN) & other documents as mentioned in the DTCN must be clear visible Scanned and uploaded in .pdf format in the web-site along with the bid.

15. The SC / ST / Engineering and other eligible contractors who claim price preference shall have to submit application/affidavit and upload the documents in the portal.

16. Any addendum / corrigendum / cancellation of above tender will be published in the web-site www.tendersodisha.gov.in and in the office notice board.

17. The authority reserves the right to cancel any or all bids without assigning any reason.
