

2. The quotation papers should fill in all respect & be reach to the under signed within the stipulated period by Speed Post/Regd. Post. The quotation through Fax/Telex/Telegram/E-mail/Whatsapp will not be accepted.
3. The quotation must have valid GSTIN registration certificate, PAN Card & other supporting documents with Tax clearance certificate should be accompany with their quotation paper.
4. The **Rs. 1%** EMD of the Bid amount shall be deposited by the intending bidders/supplier in shape of Account Payee Bank Draft drawn in favour of the Panchayat Samiti Office, Daringbadi and submitted along with the quotation paper, EMD as security deposit. After completion of quotation process, the amount will be refunded to unsuccessful bidders/Firms/suppliers.



5. The bidder shall submit a bid processing fees **Rs. 2000.00 (Rupees Two thousand)** only in favor of **BDO, Daringbadi** in shape of demand draft payable at SBI Daringbadi.
6. The rate of individual items will be mentioned as per specification inclusive of all taxes should be mentioned against each item.
7. The successful bidder should deliver the articles within 30 days soon after receipt of supply order in their own arrangement and no transportation charges will be paid. In case of failure to deliver the articles within the stipulated period the supply order shall be automatically cancelled.
