CORRIGENDUM

In continuation of Tender Notice No. 1674 dated 30.05.2026 for the construction of Additional Class Rooms (ACRs), the following corrections/modifications are hereby made and shall form an integral part of the original tender document:

1. Eligibility Criteria

The eligibility criteria mentioned in the third line of the tender notice shall be read as “C & D Class Contractors” instead of “B, C & D Class Contractors.”

2. Reference to Annex-I

The provision mentioned against Sl. No. 3 shall be read as “As per Column No. 04 of Annex-I” instead of “As per Column No. 06 of Annexure-I.”

3. Deletion of EPF/ESI Requirement

The requirement for submission of a copy of a valid EPF/ESI Registration Certificate as on the date of advertisement, mentioned under Paragraph No. 14, is hereby deleted.

4. Income Tax Returns

The Income Tax Returns mentioned under Paragraph No. 14 for the financial years 2023-24/2024-25 shall be read as 2023-24 and 2024-25.

5. Scrutiny of Abnormally Low Bids

The sentence under Paragraph No. 25(vi):

"Justification for abnormally low bids shall be scrutinized by the departmental technical committee and recommended to the competent authority of the administrative department."

shall be read as:

"Justification for abnormally low bids shall be scrutinized by the Technical Committee of Zilla Parishad, Kandhamal and recommended to the Tender Accepting Authority."

6. Correction of Typographical Error

The word “blow” appearing in Paragraph No. 25(vi) shall be read as “below.”

7. Correction Regarding APS Submission

The sentence under Paragraph No. 25(vi):

"The exact amount of APS will be submitted by the successful bidders in shape of Term Deposits pledged in favour of the CDO-cum-EO, Zilla Parishad, Kandhamal / Bank Guarantee in favour of the CDO-cum-EO, Zilla Parishad, Kandhamal."

shall be read as:

"The exact amount of APS shall be submitted by the successful bidder(s) in the form of Term Deposit pledged in favour of the BDO of the concerned Block or Bank Guarantee in favour of the BDO of the concerned Block."

8. Digit Requirement

The term "one digit" mentioned in Paragraph No. 40 shall be read as "two digits."

9. Correction of EMD Amount

Against Sl. No. 15, "Construction of ACR at Jidingimala PUPS," the EMD amount shall be read as **Rs. 15,000/- (Rupees Fifteen Thousand only)** instead of **Rs. 1,500/- (Rupees One Thousand Five Hundred only)**.

10. Deletion of Work from Tender Schedule

The work "Construction of ACR at Budaguda PS" is hereby deleted from the tender schedule. Consequently, the total number of projects covered under the tender stands revised from **78 projects to 77 projects**.

11. Correction in Mandatory Format (Sl. No. 11)

The requirement for Income Tax Returns of the last two financial years shall be read as **FY 2023-24 and FY 2024-25** instead of **FY 2022-23 and FY 2023-24/2024-25**.

12. EPF/ESI Registration Certificate

Under the Mandatory Format at Sl. No. 14, submission of a copy of a valid EPF/ESI Registration Certificate shall be **optional**.

13. Extension of Bid Submission Date

The last date and time for receipt of bids through Registered Post/Speed Post only has been extended up to **20.06.2026 at 2:00 P.M.** The bids shall subsequently be opened on **24.06.2026 at 11:00 A.M.**


All other terms and conditions of the original tender document shall remain unchanged.




