Eligibility Criteria for VCPs

Eligibility criteria for FPOs/ Cooperatives: FPO and Farmer's Cooperatives fulfilling the following criteria shall be eligible:

- I. Should be registered under the Companies Act or Cooperatives Act.
- II. Should have an experience of at least 3 years working in the district where the cluster is formed.
- III. At least 200 farmers (100 for Northeast and Hilly regions) should be registered in the FPO or Cooperative.
- IV. Average annual turn over in the past 3 years should be greater than Rs. 9 lakhs
- V. Equity of at least of Rs. 3 Lakhs by the farmers in the FPO,. Recipients of any Equity Grant by the Government shall be given preference.

Eligibility criteria for Public or Private Corporations

Public or Private Corporations fulfilling the following criteria shall be selected based on the performance matrix given at Annexure.

- I. Minimum annual turnover of Rs. 10Cr.
- II. No defaults of taxed in last 3 years.
- III. Working as a producer of seeds, fertilizers, and edible oil for at least the last 5 year.
